An Ordinance to establish the salary ranges of the City Attorney and the Municipal Judge of the City of West Allis for the four year period of May 1, 2012 through April 30, 2016.

The Common Council for the City of West Allis do ordain as follows:

PART I. The wage and salary range for the City Attorney and Municipal Judge, for the four year period of May 1, 2012 through April 30, 2016, shall be as follows:

City Attorney - Bi-Weekly Salary

May 1, 2012 through April 30, 2013 - \$4,294.40

May 1, 2013 through April 30, 2014 - \$4,380.80

May 1, 2014 through April 30, 2015 - \$4,468.80

May 1, 2015 through April 30, 2016 - \$4,558.40

Municipal Judge - Bi-Weekly Salary

May 1, 2012 through April 30, 2013 - \$2,329.80

May 1, 2013 through April 30, 2014 - \$2,376.60

May 1, 2014 through April 30, 2015 - \$2,424.60

May 1, 2015 through April 30, 2016 - \$2,473.20

PART II. All ordinances or parts of ordinances contravening the provisions of this ordinance are hereby repealed.

PART III. This ordinance shall take effect May 1, 2012 and be in force from and after its passage and publication.
