The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of June.

Incident reports:

Case # 12-004206, 05/23/2012, at approx. 0215 hrs – Shamrox, 6851 W. Beloit Rd.

On 05/23/2012, at approx. 0215 hrs, Officers were dispatched to Shamrox Bar, 6851 W. Beloit Rd. regarding a trouble call. Upon Officers arrival the altercation was over and one of the individuals involved in the fight fled the scene. Officers' investigation revealed that the person who fled - spat at a female and the other male individual who was involved in the altercation; this occurred inside the bar. Due to the lack of cooperation from witnesses / victim no charges were pursued.

Case # 12-004606, 06/02/2012, at approx. 0239 hrs - Dog House Tavern, 1641 S 68 St.

On 06/02/2012, at approx. 0239 hrs, officers were dispatched to a trouble call in the 1600 blk of 68th St. The complainant reported that there was a large fight consisting of about 20 individuals. The fight apparently ensued in the street as people were exiting the Dog House Tavern at closing time. There were numerous arrests made by officers and several people suffered significant injuries. This incident was very chaotic and required extensive resources from our department.

Case # 12-005037, 06/15/2012, at approx. 0207 hrs - Quencher's Bar, 7731 W. Becher St.

On 06/15/2012, at approx. 0207 hrs, Officers Agor and Pinter were patrolling the area of 77 & Becher when they observed two females loitering outside of Quencher's bar (7731 W. Becher St). Officers spoke with the two individuals and released them without incident; however, officers peered through the tavern's window and observed four individuals still inside the bar after closing time. Officers attempted to enter the bar, but the door was locked. Officers were able to get the attention of the bartender who opened the door for officers.

The bartender was asked why patrons were still in the bar. He stated they were helping him clean. The four individuals were subsequently cited for remaining on a licensed premise after closing. The bartender was cited for allowing patrons to remain on a licensed premise after closing.
