Dear Mayor Bell:

We recently sent a letter detailing the addition of ESPN U to Time Warner Cable's Digital Channel line-up. In an effort to accommodate the addition of ESPN U, additional channel moves have to be made. The following changes will occur effective Thursday, August 30, 2007:

- ESPN2 will move from channel 28 to channel 29
- The Golf Channel will move from channel 63 to channel 28
- Jewelry Television (formerly ACN) will move from channel 76 to channel 63
- ESPN Classics will move from channel 29 to channel 116
- The NBA Channel will move from channel 116 to channel 119
- Fuel will move from channel 117 to channel 106

Customers will be advised of these changes via billing statement messages as well as the TV Guide Channel, and promotional spots on our cable system.

Notification of Programming Change

Dear Mayor Bell:

As you know, Time Warner Cable is required to provide our local franchising authorities and our customers with a 30-day notice of any channel deletions or moves. Time Warner Cable's agreements with programmers to carry their services routinely expire from time to time. We are usually able to obtain renewals or extensions of such agreements, and carriage of programming services is discontinued only in rare circumstances. The following agreements with programmers are due to expire soon, and we may be required to cease carriage of one or more of these services in the near future.

## NBC Universal VOD and Starz/Encore

While we are hopeful that agreements will be reached to continue providing these channels to our customers, we are required to provide our customers and Local Franchising Authorities with adequate notification of any loss or possible loss of programming.
