**RESOLUTION TO APPROVE AN AMENDMENT TO USE SURPLUS 2023 PUBLIC
FACILITY COMMUNITY DEVELOPMENT BLOCK GRANT FUNDING TOWARD A
NEW ACTIVITY FOR THE ADDITION OF CURB EXTENSIONS WITH ADA
COMPLIANT CURB RAMPS AT TWO INTERSECTIONS ALONG W. BECHER ST.
AT S. 85TH ST. AND S. 86TH ST. ADJACENT TO FRANKLIN SCHOOL**

WHEREAS, the Common Council of the City of West Allis has approved the FY2023 Community Development Block Grant (CDBG) Annual Action Plan under Resolution R-2023-0611; and, **WHEREAS**, the utilization of CDBG funds for street improvement activities that meets HUD requirements for the CDBG program; and,

WHEREAS, the award of funds must be allocated to programs and activities meeting national objectives of the CDBG Program, such as assisting the needs of low-to-moderate income people and the installation of curb extensions, ADA compliant ramps, and pedestrian improvements; and,

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that it hereby allocates the FY 2023 Community Development Block Grant Action Plan relative to allocating \$16,000 of pedestrian improvement public facility activity Downtown Pedestrian Improvement funding, within the FY 2023 Community Development Block Grant Annual Plan, for the installation of two intersection curb extensions and ADA ramps along W. Becher St. at S. 85th St. and S. 86th St. near Franklin School (EXHIBIT A) for the purpose of safety and accessibility as a new activity.


