Requesting Authorization to Increase Bulk Collection Rates.**

This item was sent back to the Board for further consideration at a previous Common Council meeting. The Board did amend (3-1) our original fee recommendations to only raise fees for those items picked up by Public Works. All drop off fees would remain the same. Attached is a document showing the 2008 rates, the current rates and our original recommended rates (not as amended).

All City departments have been told to periodically review their fees. With the increased cost of labor, fuel and equipment needed to provide these services, it is necessary to make modest increases to the various charges currently in effect.

We will still be picking up 1&1/2 yard or less of brush for "free" on recycling days.

I would like to summarize our recommendations. We are keeping brush pick-up fees the same since we feel those fees impact our residents the most. Also, many times we are in the area anyway with the normal "free" 1&1/2 yard brush pick-ups.

The remaining fees generally show small increases of around \$10 per category. We still think the fees are cheap. For comparison, a privately rented 5 cubic yard dumpster would be in the range of \$150-\$200 and a 10-15 cubic yard dumpster in the range of \$400 plus.
