On 11/01/19, at approx. 1353 hrs, I was dispatched to Slurp & Burp, 1454 S 92 St, for the report of an attempted burglary. Investigation revealed a male party, later identified as Joshua A. Becker, m/w, [REDACTED], walked out of the upper unit at 0113 hrs on 11/01/19, at attempted to force entry to the side door of Slurp & Burp, causing damage to the deadbolt lock. Becker admitted to the incident and said he attempted to force entry to the business because the control for his heat is in the business and claimed it had been turned off by the owner of the bar. Becker was booked and issued local citations for burglary and criminal damage to property and later released.

On 11/2/19 at 0319hrs officers responded to Premier Sports Lounge, 1022 S 60 St for the security employee reporting that someone was trying to kill him. Officers arrived on scene and found only security officers, owners and bartenders inside the business. Security officer Steven C. Thompson, M/B [REDACTED] reported that he physically removed a customer from the business. At some point, Thompson heard numerous people yelling about the same male now had a firearm outside of the bar. Officers arrived on scene and did not locate anyone outside. Owners were unable to open any video from the business. Investigation is on-going.

**Solie reports...shots fired complaint...**

On 11/04/19, I responded to Uncle Festers, 5732 W Mitchell St, for a vandalism. Upon arrival I observed what appeared to be a bullet hole in the south window of the business. A bullet fragment was recovered on the sidewalk below the window, and additional damage was observed on the brick portion of the building as well as a gutter above the window. Video surveillance at the bar showed at least 2 rounds striking the building at 04:53:04. The shots came from the south of the business, and no vehicle is observed driving on Mitchell St when the incident occurred. No suspects identified at this time.

Johnson (m/w, [REDACTED]), who said that Stewart entered the bar around 1900hrs, and during one hour he served her 1 shot and 2 drinks. After an hour, he refused to serve her any more alcohol. Stewart said that he could not say if Stewart was already intoxicated upon entering the bar, and he was the only bartender serving Stewart drinks. No other issues observed.
