RESOLUTION R-2025-2809**

**RESOLUTION TO ACCEPT THE PROPOSALS OF TRUCK COUNTRY OF
WISCONSIN AND MACQUEEN EQUIPMENT FOR FURNISHING AND
DELIVERING ONE 2026 AUTOCAR ACX64 REFUSE TRUCK CHASSIS FOR
\$223,653 AND ONE 2026 MCNEILUS MODEL 2016 REL 20 YARD REFUSE
PACKER BODY WITH SNOWPLOW PACKAGE FOR \$217,632 FOR A TOTAL SUM
OF \$441,285**

WHEREAS, the Public Works Sanitation and Streets Division has a need to replace an 18-year-old refuse packer that has exceeded its service life. This will enhance the reliability of our refuse and snow plowing fleet; and,

WHEREAS, the 2025 approved budget includes \$450,000 for a refuse packer; and,

WHEREAS, a cooperative proposal through the Sourcewell National Cooperative Contract #032824-ATC has been received for the 2026 Autocar ACX64 Refuse Truck Chassis and Sourcewell National Cooperative Contract #110223-MCN has been received for the 2026 McNeilus Model 2016 REL 20 yard Refuse Body with Snowplow Package has been received; and,

WHEREAS, the Fleet Services Division of the Department of Public Works has determined that these contracts meet all desired specifications, and that the cooperative agreement proposals received are reasonable; and,

WHEREAS, the Common Council deems it to be in the best interests of the City of West Allis that the proposals of Truck Country of Wisconsin and MacQueen Equipment be accepted.

NOW THEREFORE, be it resolved by the Mayor and Common Council of the City of West Allis that the proposals dated June 20, 2025 by Truck Country of Wisconsin for the sum of \$223,653 and June 24, 2025 by MacQueen Equipment for the sum of \$217,632, for a total sum of \$441,285, be and are hereby accepted.

Now, therefore be it resolved by the Mayor and Common Council of the City of West Allis that the purchase of the above-described items, for an amount of \$441,285, is hereby authorized. Funding for this purchase has been budgeted and is available in the 2025 Capital Improvement Program budget. The purchase will be charged to Account Number 550-4233-535.70-03.

Be it further resolved that the Finance Department be and is hereby authorized to enter into a contract for the aforesaid equipment.
