**RESOLUTION TO APPROVE THE BID OF MJ CONSTRUCTION, INC. FOR CIP
LEAD SERVICE LINE REPLACEMENTS AT VARIOUS LOCATIONS IN THE
CITY OF WEST ALLIS IN THE AMOUNT OF \$269,100**

WHEREAS, the Board of Public Works duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in certain areas as described below, and the bids received were reasonable; and,

WHEREAS, the Board of Public Works recommends and deems it to be in the best interests of the City of West Allis that the bid of MJ Construction, Inc. for 2026 Project No. 6 be accepted.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the bid of MJ Construction, Inc. for 2026 Project No. 6 for private lead water service line replacements at:

- S. 72nd St. from W. Washington St. to the North City Limits
- S. 78th St. from W. Beloit Rd. to W. Arthur Ave.
- S. 88th St. from W. Maple St. to W. Mitchell St.
- S. 94th St. from W. Orchard St. to Dead End
- W. Mitchell St. from S. 56th St. to S. 60th St.

for the sum of \$269,100 be accepted.

BE IT FURTHER RESOLVED that the proper City officers are authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

BE IT FURTHER RESOLVED that said improvements be installed using Safe Drinking Water Loan Program funds and Capital Projects cash reserves (future reimbursement from special assessments).




