OPPOSE, because the bill would complicate and restrict the City's ability to monitor appropriate City related business in our employee's electronic mail usage.

3. OTHER

- The Legislative Committee discussed the February 27, 2009 letter from Library Board President Sr. Mary Ellen Paulson (see attached) in regards to the Library Board's opposing comments on the Legislative Committee's inclusion of the option of a regional approach to the delivery of library services in the list of legislative ideas suggested to the City's three area legislators. The Legislative Committee decided to have Mayor Devine hold off sending the letter to our three area legislators with this one item included until the City's Advisory Committee at its next Recess Committee meeting on March 17 can make a decision on this item from an official City policy position.
- The Legislative Committee heard a report on those items the League of Wisconsin Municipalities will be working on for new legislation in this session including:
 - (1) Clean up of language on statutory differences between cities and villages;
 - (2) Specifying the definition of what housing is tax exempt as it relates to low income and high-income individuals; (3) Inclusion of income rental rate consideration for leasing commercial property for assessment purposes;

- (4) Improvement of storm water regulation; and (5) Allowing neighborhood electric vehicles to be on and cross state highways.
- AB75 State Budget Bill: The Legislative Committee continued to discuss the positive and negative aspects of Governor Doyle's proposed budget. At the Committee's next meeting on March 24, a summary list of the City's position on the important aspects of the budget bill will be agreed to so that it can be sent to the State Legislature explaining what elements we favor and what elements we oppose. (The Committee noted a letter from the MCLEEA that had been sent from Chief Jungbluth noting opposition to the single license plate, the elimination of the registration decal, and the collection of traffic stop statistics.)
