

NARRATIVE

INITIAL RESPONSE

On Tuesday, 12/02/14 at 2236hrs I, Officer Kleinfeldt, with Officer Kwasinski in the same squad (squad 15) responded to a trouble call at Larry Michaels Tavern, 8900 W Greenfield Ave. Bartender Alma A Frye (F/W 02/20/71) reported an intoxicated female was fighting another patron in the tavern and had left westbound on W Greenfield Ave. I drove to the location east on W Greenfield Ave and did not observe any females in the area.

CONTACT WITH ALMA A FRYE (F/W 02/20/71)

Alma A Frye (F/W 02/20/71 was the bartender on duty. Frye stated a female described as having blonde hair and wearing a brown sweater was with her boyfriend in the tavern and was intoxicated. Frye said the female began arguing with everyone in the bar and started yelling. Frye asked the female to leave and she refused. Frye said these females yelled, "You're all finished!" and that they were all doomed, and claimed she was a cop. Frye said while telling the female to get out of the tavern, the female attempted to reach at her from over the bar but could not reach her. Frye explained another female who was not identified tried getting this intoxicated female to leave and these two females ended up struggling with each other. Frye stated she observed the intoxicated female try to hit this female and was not sure if she connected, and this was when Frye called the

police. Frye said the other female that the intoxicated one was trying to hit also left the tavern before police arrived.

CONTACT WITH ANTHONY J KIM (M/W 02/19/78)

Anthony J Kim (M/W 02/19/78) was a patron at the tavern and gave the same account of events as Frye. Kim added he separated the intoxicated female from the other female patron when the intoxicated female started fighting. Kim believed the intoxicated female and her boyfriend left westbound on W Greenfield Ave.

PROPERTY - PRESCRIPTION BOTTLE

Frye handed me a prescription bottle that was found on the floor of the tavern. It was in the name of Jodi Tegeler of Tennessee for a Zoloft prescription, and there was one half of a Zoloft pill left in the bottle. I later entered this into property under property number 14-008722-1.

ATTEMPTED SUSPECT IDENTIFICATION

Officers were unable to locate the intoxicated female. I later checked local records and CCAP and did not find any record of Jodi Tegeler. I checked this name in KGIS and found Jodi L Tegeler (F/W 05/30/72) of Greendale was arrested by Franklin PD in 2009. Tegeler comes back on file through Wisconsin and I could not find any information about her living in Tennessee as the prescription bottle states. I also do not know if Tegeler was the subject of Frye's complaint or if Tegeler was the other female that was struck by the intoxicated female.

CASE DISPOSITION

Officers were not able to locate the suspect or identify her as the subject of the complaint, there will be no further follow up with this matter.
