Michael J. Czaplewski, being duly sworn, on oath deposes and states as a complaint against D's Too, Inc. as follows:


1. That the complainant is a resident of the City of West Allis, is the duly elected Alderperson for the First Aldermanic District in the City of West Allis, is the Chairman of the License and Health Committee, and makes this complaint at the direction of the License and Health Committee of the West Allis Common Council.
2. That the information contained in this complaint comes from the complainant's review of official records maintained by the City of West Allis, which records complainant believes to be reliable and accurate.
3. That D's Too, Inc. is the holder of a Class "B" Fermented Malt Beverage License Number 12-1706, issued by the West Allis Common Council for the license period beginning July 1, 2012, and ending June 30, 2013, for the premises located at 11078 West National Avenue, West Allis, Wisconsin and does business under the trade name "D's Too."
4. That Pauline Ziegler is the registered agent of D's Too, Inc.
5. That on November 14, 2011, Department of Revenue Agent G.W. Davies notified Assistant City Clerk Monica Schultz via letter that D's Too, Inc. did not hold a valid


seller's permit under Wis. Stat. § 77.61(11). (See attached Exhibit 1.)

- 6. That per the Department of Revenue website, D's Too, Inc. has not held a valid seller's permit since May 12, 2011. (See attached Exhibit 2.)
- 7. That due to the failure to have a valid seller's permit, D's Too, Inc. has remained closed for business for more than 30 consecutive days.
- 8. That D's Too, Inc.'s conduct substantially relates to the licensed activity and is in violation of Wis. Stat. § 125.04(5)(c) and Sections 9.02(9)(c) and 9.02 (12)(d) of the West Allis Revised Municipal Code.

**WHEREFORE**, Michael J. Czaplewski requests that D's Too, Inc. be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the Class "B" Fermented Malt Beverage License of D's Too, Inc. should be revoked, suspended, or not renewed.
