The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of April.

Incident reports:

Case # 13-002728, 03/30/2013, at 0221 hrs – 8924 W. Schlinger Av. Shepherds Sports Lounge. (This Case was forwarded to Detective Bureau after the March 2013 report was submitted.)

On 03/30/2013 at 0221 hrs., Officers responded to Shepherds Sports Lounge, 8924 W. Schlinger Av for a report of 15 people fighting. Upon arrival, the Officer observed several individuals fighting in the middle of W. Schlinger Av. Darrell K. Harris attempted to evade the Officer while he was trying to stop him and speak with him about the incident. Darrell continued to walk away from the Officer and attempted to hide behind a vehicle in the parking lot of Shepherds Sports Lounge. Darrell then attempted to flee the scene and Officers took him to the ground. While on the ground Darrell fought with Officers. Several knee strikes were given to Darrell, as he would not listen to Officer commands and place his hands behind his back. Another Officer used his Electronic Control Device on Darrell to gain control of him. Another patron, Jessica L. Harris interfered with Officers multiple times while they were attempting to place Darrell in handcuffs. Darrell was arrested for Disorderly Conduct and Resisting an Officer. He was issued Municipal Citations. Jessica was arrested for Disorderly Conduct and Obstructing an Officer and issued Municipal Citations. The fight was apparently over a stolen coat.

An Officer spoke with the owner, Kevin Stanelle, who stated he had been in the bar all night, and did not observe any problems. At bar close he heard a commotion coming from outside. He looked out the window and saw several people fighting in the street. He ran outside and tried to break the fight up, but was unsuccessful. He ran back inside to call the police.

Case # 13-003184, on 04/16/2013, at 0016 – 7207 W. National Av, Tap City

On 04/16/2013, at 0016 hrs., Officers responded to Tap City for a report of a male and female fighting. Jeffrey W. Loker was assaulted by Sabrina A. Barulek. Barulek was located driving away from the tavern and stopped in her vehicle. Loker stated an altercation started inside the tavern and Barulek assaulted him by punching him several times in the face resulting in a chipped front tooth, injury to his nose and bruising to his neck. Barulek was found to be in possession of a switchblade knife and brass knuckles in her pants pocket, which she was subsequently arrested for possessing. She was also arrested for OWI – 2nd Offense.

It is unknown who notified the police department of the altercation. An Officer spoke with the Bartender, Julie Swiercz, who stated she did not witness who started the argument, she does not know what the argument was about, nor did she see who started the fight. However, she yelled at both parties multiple times to stop fighting.
