**RESOLUTION TO APPROVE BID OF UPI, LLC FOR WATER MAIN RELAY
WORK ON S. 122ND ST. FROM W. WASHINGTON ST. TO W. SCHLINGER AVE. IN
THE AMOUNT OF \$422,840.50**

WHEREAS, the Board of Public Works duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in the area described below, and the bids received were reasonable; and

WHEREAS, it is in the best interests of the City that the bid of UPI, LLC for 2026 Project No. 16 be accepted;

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the bid of UPI, LLC for 2026 Project No. 16 for water main relays and pavement restoration on S. 122nd St. from W. Washington St. to W. Schlinger Ave. for the sum of \$422,840.50 is accepted.

BE IT FURTHER RESOLVED that the proper City officers are authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City, and that all other bids received for same be rejected.

BE IT FURTHER RESOLVED that said improvements be installed with funding by bond funds.

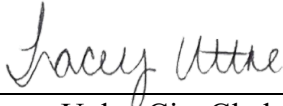

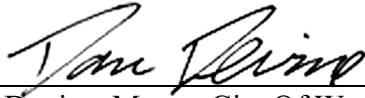
