TERMS OF 2024 PROJECT NO. 6 FOR FINAL PAYMENT OF \$2,000**

WHEREAS, LaLonde Contractors, Inc. has completed their contractual obligations in accordance with the plans and specifications therefore, attested by the approval for payment by the City Engineer.

NOW THEREFORE, be it resolved by the Common Council of the City of West Allis that the work of LaLonde Contractors, Inc. (2024 Project No.6) for the installation of concrete curb and gutter, concrete pavement, concrete sidewalk, driveway replacement, sanitary sewer relay, storm sewer installation and relay, water main relay, building services, and utility adjustments at S. 89th St. from W. Greenfield Ave. to W. Orchard St. and at S. 86th St. from W. Washington St. to W. Greenfield Ave. is accepted, and the proper City officers are authorized and directed to make settlement with the said contractor in accordance with terms of said contract.
