

#### ARRIVAL

On 08-30-13 at 0122 hrs, officers responded to GR's National Pub, 6827 W. National Ave, regarding a patron trying to fight everyone inside the tavern and refusing to leave. On arrival, I made contact with the bartender, Sarah M. Reeves, who provided the following statement.

#### STATEMENT - SARAH M. REEVES (witness)

Reeves stated a male subject wearing a blue t-shirt, blue jeans and sandals, later identified as Aaron M. Jonasen, was inside the tavern causing a disturbance. Reeves did not know why Jonasen was upset, but he was challenging everyone inside the tavern to a fight. Reeves told Jonasen on numerous occasions that he needed to leave the tavern. Jonasen refused to leave and Reeves called 911 to prevent any further problems.

Reeves stated Jonasen was highly intoxicated, but eventually he left the tavern prior to officer arrival. Reeves provided me with her bartender's license #14-264, which was valid. She also provided me with the tavern license certificate #13-001613.

#### INITIAL OBSERVATIONS

On 08-30-13 at 0122 hrs, Squad 311 responded to the tavern GR's Pub, 6827 W National Ave for a report of a male who would not leave the establishment and a possible fight. Upon arrival I was met by a group of individuals outside the tavern who stated that a male, white with blue jeans, glasses and a red shirt was running westbound from the location and that he was bleeding from above one of his eyes. I began talking with a white male who stated he was helping to get the male out of the bar, this male was identified as Brandon A. Feezor. As I spoke to Feezor officers called out that they were out with a Aaron M. Jonasen (m/w, 1-1-81), the male who ran from the bar.

ON SCENE STATEMENTS OF WITNESS - BRANDON A. FEEZOR (M/W, 10/20/83)

Brandon A. Feezor said he was inside the bar when he saw a Aaron M. Jonasen walk up to a female (unknown name) and kiss her. Feezor said this made the female's boyfriend, Kurt M. Dolan, angry and he approached Jonasen and pushed him to the ground. Feezor said because he is a bouncer at a bar (Mad Dog's Tavern) he felt that he should help and he escorted Jonasen to the other end of the bar where he closed out his tab.

Feezor said he then walked outside with Jonasen and Jonasen said he was going to fight Feezor. Feezor thought he was joking and told him to just leave. At this time Jonasen took off his glasses and placed them on the window ledge. Jonasen lunged at Feezor and Feezor grabbed his arm and pressed him against the window (he showed me a smudge on the window where Jonasen's face was). Feezor said he then let Jonasen go and told him to walk away and leave. Jonasen then lunged at Feezor again and threw a punch at Feezor with his right hand. Feezor described this punch as a "superman" punch, which he said meant Jonasen threw all of his weight behind it. Feezor said he pushed the arm away

and pushed Jonasen away from him causing him to fall to the ground. Jonasen said this was when he believed Jonasen sustained the injury, which was bleeding on his face, above his eye.

Feezor had no injuries or blood on his person. I inspected his hands and elbows and saw no signs of injury or anything which would lead one to believe he was involved in an altercation. Feezor stated he had been drinking but I did not detect any slur in his speech or lack of balance. There was a moderate odor of intoxicants on his breath. Feezor also stated that if officers were to watch a video of the incident they would see exactly what he recounted to me on the video.

Officers were not able to make any contact with Dolan while on scene so Feezor called him while on scene. Dolan stated he did not wish to speak to the police concerning this case and he hung up the phone when I tried to speak with him.

#### INITIAL OBSERVATIONS

Officer Plotkin reports... On 08-30-13 at approximately 0122 hrs, officers responded to 6827 W. National Ave., GR's National Pub, for a report of a trouble call. Upon arrival, I made contact with witness, Daryll K. Kupka, inside the above tavern.

I spoke with Kupka at that time.

#### STATEMENT OF DARYLL K. KUPKA (WITNESS)

Daryll K. Kupka stated he was drinking at the above tavern this evening. Kupka stated while drinking at this tavern, an intoxicated patron subsequently identified as Aaron M. Jonasen, kissed another patron, subsequently identified as Meghan L. Buchat, at the above tavern bar counter. Kupka stated this angered Buchat's boyfriend, who Kupka identified as Kurt Dolan, subsequently identified as Kurt M. Dolan.

Kupka stated Dolan confronted Jonasen regarding this matter and Dolan began "talking shit" to or otherwise verbally confronted Jonasen regarding Jonasen kissing Buchat. Kupka stated during this confrontation, Jonasen pushed Dolan and attempted to punch Dolan. Kupka stated Dolan did not strike/attempt to strike Jonasen during this confrontation, however, Kupka stated Dolan did push Jonasen back during this confrontation.

Kupka stated as a result of Jonasen's attempt to strike Dolan, another patron, subsequently identified as Brandon A. Feezon, attempted to break up this confrontation and escorted Jonasen outside of the tavern as a result of Jonasen's continued violent and disorderly behavior. Kupka stated once outside, of the tavern, Jonasen then attempted to strike. Feezon in which Feezon

Kupka stated Feezon did not strike/attempt to strike Jonasen during this incident. Kupka further stated Jonasen also pushed him during this incident and Kupka responded by pushing Jonasen away from him. Kupka denied striking/attempting to strike Jonasen during this incident.

Kupka stated Jonasen then began walking away west on foot on W. National Ave. from the above tavern.

Kupka was unable/unwilling to provide any further information regarding this incident at that time.

Officer Carlson reports...

#### INITIAL CALL

On 08/30/13 at approximately 0122 hours, Officers responded to 6827~W. National Ave for a report of individuals fighting. While enroute, dispatch informed Officers one of the subjects a M/W, wearing a blue shirt and glasses had left the scene. Officers located Aaron M. Jonasen, M/W, 01/01/81, walking westbound on Mitchell Ave. Jonasen had a cut across his right eye, and blood covering his hands and face.

#### CONTACT WITH AARON M. JONASEN (OFFENDER)

Officers made contact with Jonasen who was highly intoxicated, and asked him what had happened this evening. At first Jonasen stated he was just walking home. Officers informed him of the cut to his eye and Jonasen denied medical attention.

Jonasen stated he had been drinking at Nightcourt, located at 7127 W. National Ave. with some friends this evening. Jonasen stated he met a girl named Megan while he was at Nightcourt, and they played pool.

Jonasen observed Megan leave Nightcourt and he followed her to GR's pub located at 6827 W. National Ave . Once Jonasen was inside of GR's he bought a round of shots for Megan and himself. Jonasen stated Megan then kissed him.

Jonasen stated an unknown male approached and began to swear at them. Jonasen informed the M/W he did nothing wrong this evening, and he would be standing right there if he had something to say to him. Jonasen then paid his tab and walked out of the bar. Jonasen stated the M/W walked out after him and punched him in the face. Jonasen then punched him back. Jonasen then left the scene and began to walk home.

I asked Jonasen if he could provide a description of the M/W, and he stated all he could remember is that he was tall. I asked him if he could describe Megan, and he only remembered her wearing a volleyball shirt and jeans.

#### ARREST DECISION

Jonasen was arrested for Disorderly Conduct due to an incident inside the tavern. Jonasen was transported to Aurora West Allis Medical center where he

#### CALL FOR SERVICE

On 08/30/13 at 0122 hrs, I responded to GR'S National Pub for a report of a trouble call.

#### STATEMENT OF MEGHAN BUCHAT

Upon my arrival on scene, I made contact with Meghan L Buchat, F/W, 07/25/84, who stated she was inside the bar when the offender, later identified as, Aaron M Jonasen, M/W, 01/01/81, asked Meghan for a picture. Aaron asked Meghan for a kiss and she replied only on the cheek. While posing for the picture with Aaron, he turned and kissed Meghan on the lips. Meghan stated she did not want a kiss from Aaron and became upset because of this. It should be noted, while I was speaking with Meghan, she was very intoxicated. Meghan's speech was very thick and slurred and her eyes were red and glassy. Meghan dropped her cellphone multiple times while I was taking her statement. After Aaron kissed Meghan on the lips, a male inside the bar, later identified as, Brandon A Feezor, M/W, 10/28/83, engaged in a verbal argument with Aaron which continued outside the bar. While outside Aaron charged at Brandon. Brandon was able to push Aaron to the side, which caused him to fall to the sidewalk outside of the bar. Meghan could not explain what happened either inside or outside of the bar in great detail.

#### STATEMENT OF CLAUDIA DERRINGER

After speaking with Meghan, I made contact with Claudia M Derringer, F/W, 10/13/52. Claudia stated while driving home from work, she observed a male in a blue t-shirt, later identified as the offender, Aaron, outside of the bar engaged in a confrontation with other bar patrons. Claudia was traveling each bound on W National Ave while she first passed by this argument, wortside of the confidence of the con

Claudia stated, the offender, Aaron began to run towards Brandon, when Brandon took Aaron and threw him up against the window of the bar. After being thrown against the window, Aaron again charged towards Brandon. Brandon threw Aaron to the sidewalk and because of being thrown to the sidewalk, Aaron's face hit the curb on the southside of W National Ave. Aaron got up and Claudie stated, you need to stay here until the police arrive. Aaron started to run away westbound on W National Ave. Claudie stayed on scene until officers arrived.
