**RESOLUTION AMENDING THE AUTHORIZATION GIVEN TO THE CITY
ADMINISTRATOR TO ENTER INTO A CONTRACT/PROFESSIONAL SERVICE
AGREEMENT WITH ROBERT HALF TO PROVIDE TEMPORARY FINANCE
STAFFING TO MODIFY THE TOTAL SUM AUTHORIZED NOT TO EXCEED
\$55,000**

WHEREAS, the City entered into a contract/professional services with Robert Half to provide temporary finance staffing to complete its required duties and responsibilities; and

WHEREAS, the City will require these services through the end of November.
