The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of May 2017

Incident reports:

Case #17-016015 // 03 May 2017 at 0108hrs. // Just J's – 9033 W. National Ave. NO VIOLATION

Caller: Employee – Abigail A. Higgins

Disorderly Conduct / Threats: On 5/3/17, at approx. 0108hrs, Officers responded to the above address for a disorderly customer. Upon arrival, contact was made with a highly intoxicated Jeffrey L. Butts, (m/b, ______) who could barely talk. Contact was also made with the victim, Dakota J. Przybyla, (m/w, ______) who stated Jeffrey threatened to shoot him with a gun. Jeffrey was taken into custody for Disorderly Conduct, transported to the WAPD for the booking process, cited, and released. Jeffrey has a local court date of 6/12/17 at 0830hrs at the West Allis Municipal Court.

Fight / Aggravated Battery: On 05/26/17 at approximately 0345 hrs, officers responded to a check on the welfare call behind 7528 W. Beloit Rd. regarding a party down on the ground. Officers located an unidentified male subject, lying face down, who had sustained a head injury. The unidentified male subject was transported to Froedtert's Trauma Center, where he shortly thereafter underwent brain surgery. The prognosis of the party is undetermined. Despite multiple efforts, officers have been unable to identify the subject. The

subject is a white male, approximately 40-50 years old, 5'08", 180 pounds, short black hair with grey on the sides, and a brown goatee. Detective Bureau investigation on-going. ***Update: This incident was determined to be a fight between two (2) patrons of One More. An arrest has been made and the male offender (Jason M. Rengstorf, M/W) has been charged by the Milwaukee County District Attorney's Officer with Aggravated Battery. There is no update of the victim's medical status at the time of this report.

Disorderly Conduct: Officer Schweitzer reports...Disorderly Conduct at Paulie's Pub, 8031 W Greenfield Ave, on 05/26/17 at approximately 2329 hrs. Victor was highly intoxicated, uncooperative with officers and was arrested and issued a citation for Disorderly Conduct. Victor was released from the station after the booking process. A local court date has been set for 06/26/17.

Andre was released from WAPD.
