**ORDINANCE TO ADOPT STATE ADMINISTRATIVE CODE ON CAMPING
UNITS**

AMENDING SECTION 9.64

WHEREAS, Wis. Adm. Code SPS 327.06(1)(a)1. requires any city approved by the department under Wis. Adm. Code SPS 320.06 to exercise jurisdiction over the construction and inspection of new dwellings to exercise jurisdiction over the construction and inspection of new camping units;

NOW THEREFORE, the common council of the City of West Allis do ordain as follows:

SECTION 1: **AMENDMENT** “9.64 Campground And Camping Resort” of the City Of West Allis Municipal Code is hereby *amended* as follows:

AMENDMENT

9.64 Campground And Camping Resort

1. License Required. [Wis. Stat. 97.67\(1\)](#) is adopted.
2. Exceptions. [Wis. Stat. 97.67\(1g\)](#) is adopted.
3. Application Process. The application process in [Wis. Adm. Code ATCP 79.05](#) is adopted.
4. Regulations. The regulations in [Wis. Adm. Code Ch. ATCP 79](#) and [Wis. Adm. Code Ch. SPS 327](#) are adopted.
5. Discipline Process. The discipline processes in [Wis. Stat. 97.71](#) and [Wis. Adm. Code ATCP 79.08](#) are adopted.

SECTION 2: **EFFECTIVE DATE** This Ordinance shall be in full force and effect on and after the required approval and publication according to law.
