

**CITY OF WEST ALLIS
RESOLUTION R-2025-4956**

**RESOLUTION AMENDING THE EXISTING PROFESSIONAL SERVICES
CONTRACT WITH AECOM TECHNICAL SERVICES, INC. (ATS) TO PROVIDE
CONSULTING SERVICES FOR WPDES PERMIT COMPLIANCE FOR FIELD
SCREENING THE CITY'S OUTFALLS IN 2025 FOR AN ADDITIONAL SUM NOT
TO EXCEED \$21,400**

WHEREAS, Wisconsin Administrative Code NR 216 requires the City of West Allis to have a WPDES Stormwater Permit; and,

WHEREAS, in 2020, the Wisconsin Department of Natural Resources renewed the City of West Allis WPDES Stormwater Permit; and,

WHEREAS, the permit sets forth a compliance schedule for implementing various programs and activities; and,

WHEREAS, ATS has provided professional services for the City's Stormwater Utility and WPDES permit requirements since 2009; and,

WHEREAS, ATS will continue to screen the City's outfalls in 2025, as required by the WPDES Permit; and,

WHEREAS, given ATS's comprehensive knowledge of and continued involvement with the City of West Allis storm sewer system, it is cost effective and efficient to issue a request for proposals from other consulting firms.

NOW THEREFORE, be it resolved by the Mayor and Common Council of the City of West Allis that the professional services contract with ATS dated July 28, 2025 is amended to include additional field screening services for 2025 as described in the amended scope of services, for a sum not to exceed \$21,400.

BE IT FURTHER RESOLVED that the funding of such services shall be paid by the City's Stormwater Utility and charged to Account Number 540-1807-538.30-02.

BE IT FURTHER RESOLVED that the City Engineer is authorized to amend the professional services contract with ATS to effectuate this resolution.

BE IT FURTHER RESOLVED that the City Engineer is authorized to make any non-substantive changes to the approved documents to effectuate their intent and to prepare and deliver any other documents necessary to complete the approved transaction.
