Officer Behnke reports... Disorderly Conduct/Battery

On 12/06/2019 at 2052 hours, I responded to Dopps Bar, located at 1753 S. 68 St. for a report of two males fighting in the street. Investigation revealed Jefferson D. Harris (M/W), was reportedly intoxicated and instigating an altercation with Jason T. Hallman (M/W), and his fiancé, Jennifer S. Matthaeus (F/W), while inside the bar. Impartial witnesses reported that Harris intentionally punched Hallman from behind. Angela L. Etzel (F/W), removed Harris from the bar who initially left the scene in a red Jeep Cherokee. Hallman and Matthaeus exited the bar to smoke a cigarette when Harris returned in his vehicle and attempted to fight Hallman again. Hallman stated he acted in self-defense Harris who, after the two exchanged punches, Harris left the scene again. At approximately 2240 hours, Waukesha County Sheriff's Office (#W19-090678) advised that they responded to Harris' residence after Harris' roommate requested an ambulance due to his injuries. Deputy Moose of WKSO advised that Harris had facial injuries and possibly a concussion, and was transported to Froedert Hospital for further evaluation. Dep. Moose advised Harris to contact me regarding this investigation. Harris will be mailed a citation for Disorderly Conduct.
