The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of April 2009

Police report incidents involving licensed businesses:

Tavern reports:

Case # 09-002748, 04/01/09 at 2307hrs, 7420 W Greenfield Ave., Bunkers

On the above date and time officers were called to Bunker's in regards to a disorderly male. It was learned the male had been escorted out of the tavern twice earlier in the night and now was being held for kicking the owner and having to be forced out of the bar. The party had exposed himself earlier in the evening and that was why he was originally removed from the bar. The officers report reads that the owner told him that an intoxicated male came into the bar tonight and bought a beer. No violation but questionable judgment as to why we weren't called after the first event and why the party was served.

Case# 09-003035, 04/11/09 at 0001hrs, 1753 S 68 St, Dopp's

On the above date and time officers responded to a fight call in the lot at Dopp's. When they arrived the fight was over and they learned that one of the victim's was back in the bar. After talking to several witnesses including the victim it was learned that several fights had broken out during the night involving the same groups of people. The victim in the bar needed nine stitches to close a cut to the side of his face. No one from the tavern called the police or fire(rescue) according to the officers report.

Call# 09-015915, 04/16/09 at 0145hrs, 7930 W National Ave, The Jock Stop

On the above date and time officers responded to a trouble call at the Jock Stop. The event was a verbal altercation between two parties in the bar. **Employees of the tavern called the Police to prevent any problems.** Both parties were sent on their way.

Case# 09-003181, 04/16/09 at 2331hrs, 1902 S 68 St, Mugshotz

On the above date and time officers responded to a fight in front of Mugshotz. A male in the bar poured a drink over his girlfriend's head and then eventually became unruly with management and had to be physically taken out of the bar by several patrons. The report does not specify who called the police.

Case# 09-003600, 04/28/09 at 0037hrs, 6851 W Beloit Rd, Buggy's

On the above date and time Officers were called to assist a female outside of Buggy's who stated that she was assaulted by a female inside the tavern. The victim was punched several times while sitting on her barstool and when she left the offender followed her out and struck her several more times. The bartender stated she saw the altercation but did not call because she thought the incident had resolved itself.

Tobacco and Alcohol Compliance checks;

Case 09-003232, 04/17/09 at 0917hrs.

On the above date and time an officer from the West Allis PD conducted 10 random alcohol compliance checks with the assistance of a 19 year old civilian. Of the 10 checks 4 merchants failed to comply and sold to the underage party. The businesses that failed to comply were Kwik Pantry 6716 W. Lincoln Ave., Dhillon Beer and Liquor 5832 W. Burnham St., Cleveland Avenue Discount Liquor 8423 W. Cleveland Ave. and Sentry 10282 W. National Ave. See attached report for parties cited.
