**RESOLUTION APPROVING A CENTER SHARING AGREEMENT QUAD/MED, LLC  
FOR HEALTH SERVICES BEGINNING MAY 1, 2024**

**WHEREAS**, The City of West Allis provides health care and prescription drug benefits to eligible employees and retirees through a self-funded plan; and

**WHEREAS**, the City of West Allis is committed to providing employee benefits in a manner that balances recruitment and retention competitiveness with its fiduciary responsibility to the taxpayers; and

**WHEREAS**, the City of West Allis and USI our employee benefit consultant continue to review options and opportunities to mitigate costs; and

**WHEREAS**, entering a center sharing agreement with Quad/Med, LLC for health services will expand options for receiving quality care and give eligible participants increased access to medical care that provides benefits for convenient access and same day appointments.

**NOW THEREFORE, BE IT RESOLVED** by the Mayor and Common Council of the City of West Allis that the City Administrator is hereby authorized execute a Center Sharing Agreement with Quad/Med, LLC for health services beginning May 1, 2024 through February 28, 2027; and

**BE IT FURTHER RESOLVED** that the City Attorney be and is hereby authorized to make any substantive changes, modifications, additions and deletions to and from the various consulting Contract documents, including but not limited to all attachments, exhibits, addendums and amendments, as may be necessary and proper to correct inconsistencies, eliminate ambiguity and otherwise clarify and supplement said provisions to preserve and maintain the general intent thereof, and to prepare and deliver such other and further documents as may be reasonably necessary to complete the transactions contemplated therein.


