The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of January and two dates in early February.

Incident reports:

Call # 12-003484, 01/27/2012, at approx. 0137 hrs - Sports Medicine, 7731 W. Becher St.

On 01/27/2012, at approx. 0137 hrs, Officers responded to the complainants address in the 7800 block of Becher St. The complainant reported that he was drinking at the Sports Medicine Bar when employees of the bar forcibly removed him from the bar for no reason. The complainant was complaining of hip pain.

Officers' investigation revealed that the complainant was acting inappropriately towards women in the bar and he was asked to leave repeatedly by employees, which he refused. This party was physically removed from the bar; he fell on the ground along with employees who removed him. The complainant was advised that this incident would be documented; however, he should refrain from going back to the bar. He refused any kind of medical attention.

Sports Tavelly
Case # 12-000805, 01/28/2012, at 2302 hrs – Big Dogs Tavern, 9427 W. Greenfield Ave.

On 01/28/2012, at 2302 hrs, officers were dispatched to Big Dog Tavern, 9427 W. Greenfield Ave regarding a disorderly couple that just left the tavern. The male party broke a glass in the tavern and the female he was with hit another female in the face. The two parties were located in the rear parking lot. Both parties were very intoxicated and arrested for disorderly conduct, booked and issued citations.

Case # 12-000948, 02/03/2012, at 1411 hrs - The Spot Light Tavern, 6426 W. Greenfield Ave.

On 02/03/2012, at approx. 1411 hrs, officers performed a tavern check at the Spot Lite Tavern, 6426 W. Greenfield Ave. Officers confirmed that the bartender had her valid bartending license on premise. However, officers observed a dancer was who did not have her breast area covered properly. In addition, the dancer was unable to verify her identity, so officers conveyed her to the station in effort to verify her identity.

The owner of the bar was contacted, but informed Officers that she (the dancer) was not an employee of the bar; she would dance for tips only and was not on his payroll. The dancer was advised of the necessity for having her breast region covered when dancing; she was given a warning for the violation.

Case # 12-000990, 02/05/2012, at 1100 - 1400 hrs - Lynch's Tavern, 2300 S 108th St

On 02/05/2012, at 1420 hrs, Officer Schumitsch responded to the complainant's residence in the 106 block of West Lincoln Ave. The complainant reported that he believes his girlfriend was drugged while at Lynch's tavern. He stated that he and his girlfriend (who he did not know her last name) were at Lynch's Tavern between 1100-1400hrs, on this date. He estimated that his girlfriend had two Bloody Mary's and two Lynchbombs while there; once they left the bar she became very dizzy and lethargic and began vomiting. He suspected two "shady men in the bar of drugging her drink."

Investigation revealed that the intoxicated female had several drinks and also took an antidepressant pill, which had a warning on the pill bottle reflecting that alcohol may cause drowsiness and intensify the effect.

Video footage did not reflect anyone putting any drugs in the woman's drink. The female also contacted the investigator and the owner of the bar and said she did not believe she was drugged. No further investigation.

Tobacco and Alcohol Compliance checks:

- No alcohol compliance checks were performed in the month of January.
- No tobacco compliance checks were performed in the month of January.

Violation of Wisconsin Clean Air Act Smoking Ban:

There was one reported violation for the month of January.

Case # 12-000582, 01/21/2012 at 2327 hrs - (6500 Bar), 6500 W. Greenfield Ave.

On 01/21/2012, at approx. 2327 hrs, Officers were dispatched to the 6500 Tavern (6500 W. Greenfield Ave) regarding an anonymous complaint of patrons smoking in the bar. Upon officers' entry into the bar they observed two female patrons sitting at the bar, one was actively smoking and the second had a cigarette in front of her in an ashtray. Both patrons were cited for violation of the clean air act.

When questioned about the violation the one female told the officer that the female bartender told her they could smoke in the bar because she allows patrons to do so.
