**RESOLUTION TO APPROVE BID OF LALONDE CONTRACTORS, INC. FOR
BIOSWALE BUMP OUT CONSTRUCTION AT THE INTERSECTION OF S. 62ND
ST. AND W. LAPHAM ST. IN THE CITY OF WEST ALLIS IN THE AMOUNT OF
\$344,307.02**

WHEREAS, The Board of Public Works reports that it duly advertised for bids for the furnishing of certain materials and the performance of all work required for the improvements in a certain area as hereinafter described; that the bids received as shown on the attached bid report were reasonable and hereby recommends and deems it to be for the best interests of the City of West Allis that the bid of LaLonde Contractors, Inc. for 2024 Project No. 26 be accepted.

WHEREAS, Milwaukee Metropolitan Sewerage District (MMSD) hired a consultant to design the bioswales and intended to bid the project out for a contractor to construct the project using Strategic Green Infrastructure grant funding.

WHEREAS, this project was not specified in the 2024 CIP, however, will be paid with MMSD Strategic Green Infrastructure grant funds that were approved by Council in 2021 with R-2021-0844.

NOW THEREFORE, BE IT RESOLVED By the Common Council of the City of West Allis that the bid of LaLonde Contractors, Inc. for 2024 Project No. 26 for the installation of bioswale bump outs at the intersection of S. 62nd St. & W. Lapham St. including engineered soil media layer, surface mulch layer or coconut fiber mat, storm water storage layer, underdrain piping, cleanouts, observation wells, anti-seep collar, overflow structures, utility adjustments in:

S. 62nd St. & W. Lapham St. Intersection

(PLAN FILE NOS. U-2704)

for the sum of Three Hundred, Forty-Four Thousand, Three Hundred Seven and 02/100 dollars (\$344,307.02) be accepted, and the proper City officers are hereby authorized and directed to enter into contractual relations with said contractor for the performance of said work, in accordance with the prices submitted in their proposal and with the specifications of the City of West Allis, and that all other bids received for same be rejected; and,

BE IT FURTHER RESOLVED That said improvements be funded with Milwaukee Metropolitan Sewerage District (MMSD) Strategic Green Infrastructure grant funds.
