WHEREAS, the City is considering vacating and discontinuing a Street Right-of-Way South of West Maple Street between South 88th Street and South 90th Street.

NOTICE OF HEARING

The Common Council of the City of West Allis will hold a Public Hearing on June 19th, 2007, at 7:00 p.m., or as soon thereafter as the matter may be heard, in the Common Council Chambers of the City Hall, 7525 West Greenfield Avenue, West Allis, Wisconsin, upon the Resolution herein described and will act upon said Resolution at said time and place. Said Resolution was introduced into the Common Council of the City of West Allis on May 1st, 2007, and proposes the discontinuance and vacation of a Street Right-of-Way South of West Maple Street Between South 88th Street and South 90th Street, legally described as follows:

That portion of South 89th Street as mapped, platted and dedicated as part of Conrad's West Allis Gardens, being a duly recorded subdivision of a portion of the Northwest ¼ of Section 4, Township 6 North, Range 21 East, in the City of West Allis, Milwaukee County, State of Wisconsin, more particularly described as follows:

Beginning at the Northeast corner of Lot 1, Block 10 of said subdivision; thence Easterly, 60.00 feet, along the South right-of-way line of West Maple Street, to the Northwest corner of Lot 12 in Block 9 of said subdivision; thence Southerly, 130.00 feet along the East right-of-way line of South 89th Street, to the Southwest corner of said Lot 12, and North right-of-way line of Union Pacific Railroad; thence Westerly, 60.00 feet, along the said North right-of-way line to the Southeast corner of said Lot 1; thence Northerly, 130.00 feet to the Point of Beginning.

Description contains 7799.3022 square feet, more or less.
