The meeting was called to order by Mayor Devine at 7:00 p.m.

Karen Jasniewski, 2908 S. 114 St., stated her concerns with regard to parking, dropping off children all at once, and traffic.

Gerald Matter, 11426 W. Montana Ave., stated his concerns relative to the residential zoning classification. The use should be for daytime and early evening, but not around the clock. He said this proposal does not fit in a residential neighborhood.

Donald Reichartz, 2903 S. 114 St., commented on his concerns relative to the total number of people, and garbage smell and removal. He asked if there was a maximum amount of people for the second shift, and questioned the other location and support from Carroll College.

Mike Evans, 2860 S. Root River Pkwy, relayed his concerns regarding increased traffic and lighting, and asked about the possibility of sidewalks.

Richard Metzger, 2929 S. Wollmer Rd., addressed his concerns regarding the daycare operation, traffic, and safety of the children. He requested peace and quiet during the second shift and on weekends.

Richard Templin, 2820 S. 114 St., shared similar concerns. He commented on the underestimation of parking. He said the variance from the standard is a mistake, and that

there are a number of issues relative to dropping off young children such as the condensed time frame and where to enter and exit. He commented on the hours of operation. He requested that alternatives be evaluated, and that the background of the organization be looked at.

Carol Sperka, 2825 S. 114 St., addressed her concerns regarding the daycare program, the possibility of sidewalks, shared a similar viewpoint with her neighbors, and said that there is no need for it since other nearby facilities exist. Her main concern related to the hours of operation. She inquired about the age of the children and the adult programs. She requested clarification and definition of the population that is going to be served. She commented on the impact of the facility on the neighborhood, and asked that other options be looked at similar to LaFollette Apartments or the old library on S. 75 St.

Karin Gale, 2831 S. 114 St., stated that the community needs adult day care for those with disabilities, and Irving is not sufficient. She said that similar concerns have existed in the past with other senior living facilities. She said the daycare drop off has some issues. She requested open mindedness and making a well-informed decision, and commented on being concerned with what else could be placed in the facility.

Becky Murray, 2875 S. 93 St., said she was interested and thrilled when she found out this facility was interested in locating in West Allis. She said the facility would be dream come true for young adults with disabilities and for parents who work longer hours, and she requested the proposal be approved.
