## NON-PAYMENT OF PERSONAL PROPERTY TAXES

Last year, the License and Health Committee granted me authority to enter into payment arrangements for delinquent personal property taxes with businesses so that they were able to retain their licenses. As per the agreement with Scardina's Bakery, Sue Scardina agreed to pay \$5,000 in December, \$2,000 in January, and \$2,000 in February. As of February 26, 2010, Scardina still owes \$3300 for the month of December and the entire outstanding balances for January and February. It should be noted that Scardina wrote a \$2,000 check for part of the December payment, but the check bounced.

Greenfield Ave., West Allis, WI. Failure to appear may result in the City commencing an action seeking the ultimate revocation of your license.
