Michael J. Czaplewski, being duly sworn, on oath deposes and states as a complaint against Gregory Steffek as follows:

- 1. That the complainant is a resident of the City of West Allis, is the duly elected Alderperson for the First Aldermanic District in the City of West Allis, is the Chairman of the License and Health Committee, and makes this complaint at the direction of the License and Health Committee of the West Allis Common Council.
- That the information contained in this complaint comes from the complainant's
 review of official records maintained by the City of West Allis and the West Allis
 Police Department, which records complainant believes to be reliable and accurate.
- 3. That Gregory Steffek is the holder of "Class B" Intoxicating Liquor & Class "B"

 Fermented Malt Beverage License Number 1380, Dance Hall License Number 1382, and Instrumental Music License Number 1383, issued by the West Allis Common Council for the license period beginning July 1, 2010, and ending June 30, 2011, for the premises located at 1902 South 68th Street, West Allis, Wisconsin and does business under the trade name "Mugshotz."
- 4. That on February 10, 2011, at approximately 1:24 a.m., West Allis Police Officer Timothy Gold arrested and cited Gregory Steffek for operating while intoxicated,

- operating with a prohibited alcohol concentration, and possession of drug paraphernalia.
- 5. That Steffek's blood alcohol concentration was .14; the legal limit in Wisconsin for blood alcohol concentration is .08.
- 6. That Steffek told Officer Gold that he was coming from Mugshotz, that he had been drinking at Mugshotz since 6 p.m., and that he had consumed approximately eight beers.
- 7. That after placing Steffek under arrest, Officer Gold recovered from Steffek's pocket a smoking pipe that emitted a pungent odor and was charred inside.
- 8. That based on Officer Gold's training and experience, he recognized the pipe as one that was used for smoking marijuana.
- 9. That Steffek told Officer Gold that he had been smoking marijuana for the past 30 years and that there possibly could be some marijuana in his car.
- 10. That Officer Gold searched the vehicle and discovered a vial of hash oil in the car's middle console.
- 11. That Steffek was found guilty of operating while intoxicated and possession of drug paraphernalia. The operating with a prohibited alcohol concentration citation was dismissed pursuant to plea negotiations.
- 12. That Steffek has violated the provisions of Chapter 125, Wis. Stats. and 9.02(12)(d) of the West Allis Revised Municipal Code.
- 13. That Steffek's admitted use of controlled substances renders him a habitual law offender under Wis. Stat. § 125.04(5)(b), and, as such, he is not qualified to possess a Class B Tayern License, Dance Hall License, or Instrumental Music License.

WHEREFORE, Michael J. Czaplewski requests that Gregory Steffek be summoned to

appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the Class B Tavern License, Dance Hall License, and Instrumental Music License of Gregory Steffek should be revoked, suspended, or not renewed.
