## AMENDMENT TO THE SOUTHWEST SUBURBAN HEALTH DEPARTMENT AGREEMENT

This Amendment to the Southwest Suburban Health Department Agreement ("Agreement"), effective as of the date last executed by any party below, is made and entered into by and between the City of West Allis ("West Allis") and the City of Greenfield ("Greenfield") to extend the time for the Village of West Milwaukee ("West Milwaukee") to decide whether it would like to become a member of the Southwest Suburban Health Department ("SWSHD").

## **RECITALS:**

- A. On March 28, 2024, Greenfield and West Allis executed an agreement to establish the SWSHD.
- B. West Milwaukee has requested an extension of time to decide whether to become a member of the SWSHD.
- C. West Allis and Greenfield are willing to extend West Milwaukee's time to make a decision, which is currently required by January 1, 2025.

## IT IS MUTUALLY AGREED AS FOLLOWS:

1. Section 3(b)(iii) of the Agreement is hereby amended to read as follows:

The Village of West Milwaukee ("West Milwaukee") presently contracts for health department services and has a member on the SWSHD Board. West Milwaukee will have until June 30, 2025, to decide whether it wishes to become a member of the SWSHD or remain in a contracted services agreement arrangement with the SWSHD. A municipality that joins as a member shall be entitled to appoint a voting member to the SWSHD Board. Alternatively, those in a contracted service agreement shall be entitled to appoint a non-voting liaison member to the SWSHD Board. With respect to West Milwaukee, whether its member will be a voting member or a non-

voting liaison member as of July 1, 2025, shall be determined by its decision on membership.

2. Except as set forth in this Amendment to the Agreement, the Agreement shall remain in full force and effect.
