RESOLUTION R-2021-0644**

**RESOLUTION TO AUTHORIZE THE PURCHASE OF ONE 2022 RAM 1500
TRADESMAN 4X2 PICK-UP TRUCK FROM EWALD AUTOMOTIVE GROUP FOR A
SUM OF \$28,220.50 AND OF BIRD LADDER FOR FURNISHING ONE ALUMINUM
LO-SIDE TOOLBOX (184-5-03) FOR THE SUM OF \$625, FOR A TOTAL OF \$28,845.50**

WHEREAS, the Public Works Electrical Division is in need of replacing a 16 year old pick-up truck #57, with a new, more efficient and functional pick-up truck; and,

WHEREAS, the 2021 approved budget includes \$32,150 for the purchase of the pick-up truck; and,

WHEREAS, Ewald Automotive Group, the State of Wisconsin contract holder, has provided pricing for the 2022 pick-up truck vehicle for the Public Works Electrical Division of the City of West Allis; and,

WHEREAS, the Fleet Services Division of the Department of Public Works has determined that this contract meets all desired specifications, and the proposal received is reasonable; and,

WHEREAS, the Common Council deems it to be in the best interests of the City of West Allis that the proposals of Ewald Automotive Group and Bird Ladder be accepted.

NOW THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the proposal dated October 1, 2021 by Ewald Automotive Group for furnishing and delivering one (1) 2022 Ram 1500 Tradesman 4x2 pick-up truck for \$28,220.50 and the proposal dated August 23, 2021 by Bird Ladder for furnishing and delivering of one (1) 184-5-03 aluminum lo-side toolbox for \$625 for a total net sum of \$28,845.50 be and is hereby accepted.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Common Council of the City of West Allis that the purchase of the above described items, for an amount of \$28,845.50, is hereby authorized. Funding for this purchase is available in the General Fund, Public Works Budget and the purchase will be charged to Account Number 352-4118-533.70-03, Vehicles.

BE IT FURTHER RESOLVED that the Finance Department be and is hereby authorized to enter into a contract for the aforesaid equipment.
