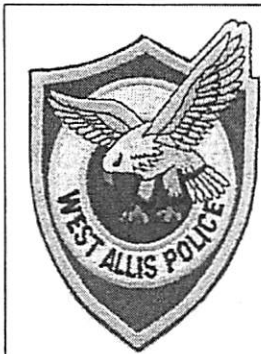

**INITIAL CALL/STATEMENT OF TAMMY S. DUNAWAY**

On 11/29/14 at approximately 0338 hrs., I was driving through the CBS/Blast Fitness parking lot, located at 935 S. 60 St., when I was waved down by Tammy Salinas Dunaway, F/W, 01/28/73. Dunaway informed me that the owner of 1022 Pub was still serving alcohol, and she just observed patrons smoking outside of the bar and then go back into the bar.

Dunaway lives at 1012 S. 60 St., which is located next door to the bar. Dunaway stated it is a common occurrence for the owner to continue to serve alcohol after the bar is closed for evening. Dunaway also informed me that she believes there is a lot of drug activity occurring at the bar because she has observed used needles on the ground by the bar.

**CONTACT AT PUB 1022**

I informed Officer Meyer and Officer Kuhnmuensch about the contact with Dunaway, and we decided to do a tavern check. Upon arrival at Pub 1022, Officer Meyer stated he could see patrons inside of the bar. I then walked to the back of the tavern to make sure nobody fled from the rear of the bar as Officer Kuhnmuensch knocked on the front door.

While standing at the back door, I heard a loud commotion and people talking loudly. I then determined that Officer Kuhnmuensch had made contact inside the bar. I walked towards the front and entered the bar.

Contact was made with the owner, Vincente Lozano, M/W, 12/19/71, who was in charge of the bar for the evening. Also on scene were 3 patrons, Dustin A. Rone, M/W, 03/23/89, Samantha R. Carr, F/W, 10/16/90 and Roslyn Lee, F/W, 07/22/69. Lee, Rone and Carr were still inside of the bar drinking alcohol.

Lozano was informed that it was after the legal time for the bar to be open and serving alcohol and that he should not have open bottles of beer on the bar. Lozano admitted to serving alcohol after the bar was closed. I informed Lozano about the citation that I would be mailing him and that he must appear for the court date. Lozano stated he understood. Carr, Lee and Rone were also informed of the citation that would be sent to them by mail.
