An Ordinance to amend Ordinance No. 2006-0028 establishing the salary ranges of certain employees in the Administrative & Clerical Service of the City of West Allis for the years 2006-2007 (Victim Advocate).

PART I. The Attachment 3 of Salary Ordinance No. 2006-0028 shall be amended by adding the new position of Victim Advocate to the salary ranges of A20(R) and A20(P).
