The following is a synopsis of reported incidents involving licensed businesses, including reported tavern violations and calls for police service for the month of July 2009

Police report incidents involving licensed businesses:

Tavern reports:

Case 09-005617, 06/26/09 at 0205hrs. 57 Bar, 1933 S 57 St.

On the above date and time officers were called to investigate a complaint of battery outside of the 57 Bar. The victim/complainant stated that he was talking to two Hispanic males in the bar and left with them at bar closing. Once outside both males attacked him punching him in the face and head several times. The bartender stated there was no problem in the tavern and never knew there was a fight outside until she was informed of such by responding officers. Both parties were identified, arrested and given municipal citations for Battery.

Case 09-005675, 06/28/09 at 0152hrs. Flappers Tavern, 7527 W Becher St.

On the above date and time officers were called to a fight outside of Flappers Tavern involving 8 parties. The complainant was the bartender who stated that the incident started over two parties trying to leave the bar with their bottles of Miller Lite beer. The bartender stated that one of the males tried to strike him and that he defended himself punching the party in the face. The party then entered a vehicle driven by his friend who made a U turn and attempted to run over the bartender and a party who came to assist him. The driver of the vehicle was eventually identified but the bartender no longer wished to pursue the matter.

Case 09-005863, 07/03/09 at 1550hrs. Ubie's Double Vision, 5501 W Burnham St.

On the above date and time officers were sent to investigate an assault call at Ubie's Double Vision. The complainant who was an employee of the tavern stated she was escorting two woman out of the bar who were causing a disturbance when one of them slammed the door on her ankle causing her pain. Both parties were arrested for Disorderly Conduct.

Case 09-005871, 07/03/09 at 2013hrs. Spotlite, 6426 W Greenfield Ave.

On the above date and time officers responded to a call from the bouncer of the Spotlite in regards to an intoxicated male refusing to leave. The male was eventually removed by officers and arrested for Disorderly Conduct.

Call 09-029751, 07/04/09 at 0154hrs. Mario's, 1900 S 60 St.

On the above date and time a bouncer at Mario's bar flagged down an officer informing him that they had kicked a female out of the tavern for harassing another patron. Party was told to leave and informed that she would be arrested if she came back.

Case 09-005908, 07/05/09 at 0216hrs. Czars Tavern, 6901 W Beloit Rd.

On the above date and time officers responded to a call from the bartender at Czars tavern in regards to an assault that took place in the bar. A patron stated that a party was staring at him and when he told him to stop the party jumped him. During the altercation a female patron was knocked to the ground and struck her head. The party fled with a friend. As of this time the party has not been identified.

Case 09-005978, 07/06/09 at 0000hrs. Harry O's, 6743 W Lincoln Ave.

On the above date and time officer responded to a call for assistance from the bartender at Harry O's in regards to a domestic violence taking place in the bar. A male subject was arrested for Domestic Violence Disorderly Conduct.

Case 09-006125, 07/10/09 at 2323hrs. Happy Tap, 6801 W Beloit Rd

On the above date and time officers took a complaint from a party who stated he was at the Happy Tap earlier in the day where he was struck twice in the back of the head by an acquaintance. Through investigation it was determined there was not enough information to prove the parties complaint. During the investigation officers felt the bartender Janice F Schirripa was not cooperating with them. She was given a local citation for breaking ordinance 9.02 (12)(b), which deals with cooperating with the police during an investigation at a licensed premise.

Call 09-032028, 07/17/09 at 0021hrs, Mario's, 1900 S 60 St.

On the above date and time an officer observed a large group in the street in front of Marios. When officers approached all but three parties went inside one of which was a bouncer at the bar who stated he was breaking up a shoving match. One of the other parties present was found to have a valid warrant and arrested.

Case 09-006604, 07/25/09 at 0156hrs, Smokin Joes, 6139 W Beloit Rd.

On the above date and time officers were called to a noise complaint (loud music) at Smokin Joes. The complainant was a neighbor. When officers approached a side door was propped open and the music could be heard outside. Since 05/07/09 there have been 11 other loud music complaints in regards to this tavern. The owner was cited for Disorderly Conduct Noise/Nuisance.
