**RESOLUTION ACCEPTING WORK OF POBLOCKI PAVING CORPORATION FOR THE CONSTRUCTION OF AN ASPHALT PARKING LOT, PERMEABLE INTERLOCKING CONCRETE PAVEMENT SYSTEM, CONCRETE CURB AND GUTTER, STORM SEWER, PAVEMENT MARKING, LANDSCAPING AND UTILITY ADJUSTMENTS IN THE WEST ALLIS PUBLIC LIBRARY PARKING LOT LOCATED AT 7421 W. NATIONAL AVE. AND IN A WEST ALLIS DOWNTOWN PARKING LOT LOCATED BETWEEN S. 72 ST. AND S. 73 ST., NORTH OF GREENFIELD AVE. IN THE CITY OF WEST ALLIS AND AUTHORIZING AND DIRECTING SETTLEMENT OF SAID CONTRACT IN ACCORDANCE WITH CONTRACT TERMS OF 2019 PROJECT NO. 5 FOR FINAL PAYMENT IN THE AMOUNT OF \$4,000 OF THE \$1,014,813.76 TOTAL PROJECT COST**


