The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of June 2018:

INCIDENT REPORTS:

There were no incidents that were tavern related in the month of June requiring a full police incident report

TAVERN RELATED INCIDENTS NOT REQUIRING INCIDENT REPORT:

CALL #18-024128// 23 June 2018 at 0021hrs// Alibi Bar- 6540 W Grant St
NO TAVERN VIOLATION

Caller: Tavern Employee

DISORDERLY CONDUCT: On 06/23/18 at approximately 0021hrs, officers responded to the Alibi, 6540 W Grant St, for a report of a bar fight. I made contact with employee, Jennifer M. Munson (F/W [REDACTED]), who advised all individuals involved left the bar before officer arrival. Jennifer stated she did not know any of the individuals fighting as they were not "regulars" at the Alibi. Jennifer did not observe anyone with a major injury nor did officers locate any blood indicating injury. I confirmed Jennifer had a valid bar tenders license (19-154) and the Alibi had a valid liquor license (17-00001663).

INVESTIGATING CITIZEN COMPLAINT RELATED TO PRIOR INCIDENT

SUSPICIOUS ACTIVITY: On 06/28/18 at approximately 2120 hours, officers conducted a tavern check at The Alibi Bar (17-1663) in response to a civilian complaint. Contact was made with licensed bartender, Stuart L. Kuhlmann M/W [REDACTED]. Stuart advised he also bounces at the bar and was made aware of the recent issues that have come about in the bar. He advised he would do his best to keep crowds under control when working. Officer discussed issues related to civilian complaints to include drug activity in the tavern as well as security to be sure there are no future problems at the tavern. Officer observed no other issues on this date and will continue to perform random tavern checks at this establishment.

**CALL #18-025372// 30 June 2018 at 0220hrs// T & T Sports Bar- 5906 W Burnham St
PROHIBITED SERVING OF ALCOHOL**

On 06/30/18 at 0220hrs, I conducted a tavern check at T&T Sports Bar, as I had received an email from Sgt. Manthe regarding the business not being allowed to sell alcohol per an order by the city clerk's office "midnight June 30, 2018, Saturday Night" (unknown if this meant Saturday morning from 0000hrs-0230hrs, or after 2359hrs on Saturday night). I spoke with the bartender, Sonya R. Bautista, F/W [REDACTED] (19-286). Patrons were inside the business and alcohol was being sold, and Bautista was unaware of any such order by the city clerk's office. She stated the owner, Tina Minto, had come by earlier in the day and dropped off two receipts that I observed were from the City of West Allis, which Bautista believed was payment for the tavern license renewal. This information was forwarded to Sgt. Manthe.

Tobacco and Alcohol/ Tavern Compliance Checks

Tobacco compliance checks:

NO VIOLATIONS DURING THE MONTH OF JUNE 2018 (Report #18-023367)

On 06/18/18 from approx. 1100hrs to 1500hrs, the West Allis Police Department conducted a tobacco check at 11 randomly selected West Allis businesses that have a license to sell tobacco. The checks were completed through the use of a 16 year old female who attempted to purchase a pack of nicotine products with authorization from the West Allis Police Department. All of the 11 business requested identification from the underage female and declined the transaction.

Alcohol compliance checks:

VIOLATION- SALE OF ALCOHOL TO UNDERAGE PERSON- RUPENA'S 7641 W Beloit Rd

Officer Mussatti reports : Alcohol compliance checks were completed at 13 businesses licensed to sell alcohol. 12 of the 13 businesses would not complete the transaction without the proper ID. Rupena's allowed the sale of an alcoholic beverage to an underage party. The cashier, Camille Cieszynski, was issued a citation for the incident.

Tavern compliance checks:


No violations reported during this reporting period.
