

**CITY OF WEST ALLIS
RESOLUTION R-2024-0099**

**RESOLUTION APPROVING AN AMENDMENT TO THE NEIGHBORHOOD
SMALL GRANT AGREEMENTS AND GRANT APPLICATIONS**

WHEREAS, the Mayor and Common Council of the City of West Allis, along with staff and citizens, recognize the importance of developing and maintaining healthy neighborhoods throughout the community; and,

WHEREAS, the Common Council of the City of West Allis under Resolution R-2014-0099 the City of West Allis Neighborhood Small Grant Program provides small grants to help organize neighborhood associations and to provide grants for neighborhood enhancement projects; and,

WHEREAS, in order to obtain the Organizational Grant or Focus Grant an organizing or established neighborhood association must first apply via cities only platform; and,

WHEREAS, the Organizational Grant shall offer a total available grant amount up to \$1,000 for first time organizing Neighborhood Associations shall be deposited in association's financial institution account in the full requested amount by Electronic Funds Transfer (EFT) upon application approval (Organizational Grant agreement) is hereby attached EXHIBIT A; and,

WHEREAS, the Focus Grant shall offer a total available grant in the amount up to \$2,000 in accordance with program policies, and based on availability of funding, shall be reimbursed upon request within the application approval year (Reimbursement Form) is hereby attached with the coordinating Focus Grant agreement EXHIBIT B, and,

WHEREAS, every neighborhood association upon approval of the Focus Grant shall request reimbursement from the City at one hundred percent of the requested, and approved, grant amount without a matching contribution towards the approved project (Focus Grant agreement) is hereby attached EXHIBIT C, and

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that it hereby has reviewed the request to deposit up to \$1,000 of the Organization Grant by Electronic Funds Transfer to first time organizing neighborhood associations and reimburse recognized neighborhood associations at one hundred percent of approved projects for the Focus Grant, up to \$2,000, under the City of West Allis Neighborhood Small Grant Program.

BE IT FURTHER RESOLVED that neighborhood associations organizing through the Organizational Grant and formally recognized through the Focus Grant shall apply electronically, via cities online platform, for available grants under the City of West Allis Neighborhood Small Grant Program, upon the approval from the West Allis Common Council.
