D. NEW AND PREVIOUS MATTERS

2.	<u>25-0025</u>	Consideration relative to the Financial Report for the period ending

11/1/25 presented by Devan Gracyalny, Vice Chair/Treasurer.

Mr. Gracyalny reported no major changes; soup sales remain strong. The running

balance total is currently \$2,441.36.

3. <u>25-0026</u> Report from the West Allis Historical Society.

Mr. Gracyalny reported a great turnout for Haunted Honey Creek. He said that the Society is working on multiple Eagle Scout projects. In addition to that, they are working

on collaborations with Harley Davidson and the Pettit Center.

4. <u>25-0106</u> Discussion regarding the Log Cabin on Historical Society grounds.

Mr. Gracyalny shared that repairs have been made to the roof to stop the leaking, but

they will likely need to replace the roof in the coming years.

5. <u>25-0246</u> Discussion regarding time capsules obtained from St. Aloysius Church.

Carson Coffield shared that there have been discussions with City Marketing Staff and that they are open to assisting Mr. Gracyalny in recording the opening and explanation of

the St. Aloysius Church time capsules in 2026.

6. 25-0332 Update on nominations as part of Subgrant for National Register of Historic

Designation.

Carson Coffield shared that Mt. Hope Lutheran Church is still awaiting approval from the National Park Service, but it has been delayed due to the government shutdown.
