**1354 South 117<sup>th</sup> Street**

Attached is a request from Dr. Allyn Coleman to remove four slabs of sidewalk at 1354 South 117<sup>th</sup> Street. Removing four slabs isn't a big deal as long as it doesn't lead to other requests like removing sidewalk along a whole block.
