**RESOLUTION TO AUTHORIZE THE FIRE DEPARTMENT TO ACCEPT FUNDING
UNDER THE BUREAU OF JUSTICE COMPREHENSIVE OPIOID, STIMULANT,
SUBSTANCE USE PROGRAM (COSSUP) GRANT**

WHEREAS, the West Allis Fire Department (WAFD), will use the federal funding to initiate programming that will curb stimulant use in the community which causes significant harm to residents.

WHEREAS, grant funding of \$1,300,000.00 over three years may be used by WAFD.

WHEREAS, funding would allow for the allocation of a community paramedic, peer counselor, and fire administrator to execute the grant deliverables.

WHEREAS, the grant will provide residents with education, harm-reduction materials, and connections to recovery programs that are evidence-based and proven to reduce stimulant use.

WHEREAS, the grant would span from October of 2024 to October of 2027.

NOW THEREFORE, BE IT RESOLVED by the Common Council of the City of West Allis that WAFD be granted permission to accept the 2024 COSSUP grant award.
