## RESOLUTION GRANTING A PRIVILEGE FOR ENCROACHMENT (MAJOR) TO NEW OWNER CAMINOWA LLC FOR PROPERTY LOCATED AT 7211-13 W. GREENFIELD AVE. (TAX KEY NO. 453-0089-000)
