The following is a summary of reported incidents involving licensed businesses, including reported tavern violations and calls for police service during the month of July 2017

**Incident reports:**

**Case #17-024696 // 01 July 2017 at 0051hrs. // Bottoms Up – 7127 W. National Ave.  
NO VIOLATION**

**Caller: Patron / Girlfriend of victim – Julie M. Dahms**

**Substantial Battery & Probation Violation:** On 07/01/17 at 0051 hours I was dispatched to Bottoms Up, 7127 W National Avenue for an assault complaint. Investigation determined Leroy K Rushing M/W punched Daniel R Goralski M/W in the face three times till he knocked him out. Goralski received a left nasal bone fracture and decreased visual acuity. Rushing was arrested and found to be on probation. Rushing was charged with Substantial Battery and Probation Violation.

**Sexual Assault:** On 01 July 2017, an adult female called the West Allis Police Department to report being 'groped' the night before (after midnight on 01 July) at Benno's. The incident was investigated and closed with no arrest being made.

**Disorderly Conduct / Fighting:** On 07/08/17 at approximately 2337 hrs. officers were dispatched to 9033 W. National Ave. for a report of a physical fight inside the bar. Investigation revealed, Lee J. Berge (m/w) sustained a laceration to his left eye after being involved in a physical altercation with an unknown subject. The offender fled before officer arrival and was not located. The suspect is described as being a darker skinned m/w wearing a grey shirt with a buzzed style haircut. Berge advised he did not want anything done regarding the fight. A report for record was completed.

Case #17-026085 // 09 July 2017 at 1928hrs. // Caterina's Restaurant – 9104 W. Oklahoma  
VIOLATION: Operate Licensed Premise without Licensed Person Present

Caller: Officer initiated license check

**License Violation:** On 07/09/17 at 1928 hrs., I conducted a tavern check at Caterina's Restaurant (9104 W. Oklahoma Ave). I spoke with the bartender, Desiree L Rolbiccki, who did not have a bartending license. No one in the establishment could produce a bartending or managers license. The owner, Antonio G. Ingrilli, was contacted and responded to the restaurant. Antonio stated Desiree was hesitant to obtain a bartending license because of an OWI. Antonio stated he had to take his child to Menomonee Falls and briefly left. Antonio stated another employee had a license and normally worked when he did not. Antonio stated Desiree would be obtaining a license now.

Case #17-026241 // 10 July 2017 at 2219hrs. // Spot Lite – 6426 W. Greenfield Ave.  
NO VIOLATION

Caller: Owner – Audrey Bomback

**Counterfeit Bill Passed:** On 7/10/17 at 2219hrs officers responded to the Spot Light for a fraud complaint. Audrey M. Bomback, f/w, said a black male, about 5'6", average build, in his 40s, wearing a black shirt, black baseball hat with orange on the brim, and dark gray shorts, asked for change for a \$100 bill. Audrey took the bill and immediately could tell the bill was fake. The bill had "For motion picture use only" on the front. Audrey called police, but the man left in a silver Mitsubishi Montero SUV (unknown plates) prior to officers' arrival. Investigation continues.

**Case #17-026390 // 11 July 2017 at 2329hrs. // Stallis Palace – 8812 W. Greenfield Ave.  
NO VIOLATION**

**Caller: Owner – Thomas E. Daniels**

**Weapons Call / Domestic Violence / OWI / Disorderly Conduct:** On 7/11/17 at about 2329hrs, officers responded to Stallis Palace 8812 W Greenfield Ave for a weapons call. The owner of the bar, Thomas E. Daniels (M/W ), called 911 to report a customer pointed a firearm at another customer and then left the scene. Officers arrived on scene and spoke with witnesses who described the suspect as a white male, who left the scene in a newer light green Kia Soul in an unknown direction. On scene I spoke with Christine L. Casso (F/W ) who identified the offender as Forest D. Cvikl (M/W ) who is her live-in boyfriend. Forest was located driving the above vehicle near S 83 St/W Arthur Ave and a pellet gun (pistol) was located in the vehicle. Forest was ultimately arrested for OWI-1st Offense, Domestic Violence Disorderly Conduct and Misdemeanor Disorderly Conduct. Forest was able to post bail and was released to a responsible party. A CO2 BB gun was recovered from the offender's vehicle. This case will be reviewed by the Milwaukee County District Attorney's Office on 7/13/17 at 0830hrs.

**Case #17-027068 // 16 July 2017 at 0252hrs. // Natty Oaks – 11400 W. Oklahoma Ave.  
NO VIOLATION**

**Caller: Anonymous passerby**

**Domestic Violence / Disorderly Conduct:** On 07/16/17 at approximately 0252 hrs., officers responded to 11400 W. Oklahoma for a report of 2 male subjects physically fighting. Upon arrival, officers located Trevor J. Kruzick who had blood on his face. Kruzick advised he and his brother, Troy T. Kruzick had a physical fight at Natty Oaks inside the bar. Troy and Trevor's mother had just passed away and they had the funeral that day. Peter A. Kruzick broke up the fight and all three of them walked towards home. While walking, Trevor threw Peter to the ground causing redness to his neck. Trevor was arrested for DV/DC and posted bail. This case to be reviewed on 07/17/17 at 0830 hrs.

**VIOLATION: Operate Licensed Premise without Licensed Person Present**

**Caller: Officer initiated license check**

**License Violation:** On 07/17/17 at 2036 hrs., I conducted a tavern check at Hampton Inn (8201 W. Greenfield Ave.). Investigation revealed the bar was being operated without a licensed bartender. The bar was closed for the evening and a citation was issued to the business.

**Call #17-026401 // 12 July 2017 at 0112hrs. // Remedy – 1309 S. 60 St.**

**VIOLATION: Selling Alcoholic Beverage to Intoxicated Person – No citation issued**

**Caller: Employee – Heather M. Crisp**

**Disorderly Conduct:** On 07/12/17 at 0112hrs, officers responded to 1309 S. 60 St. for a disorderly conduct call. Investigation revealed Miranda L. Garcia, F/H was intoxicated and began throwing napkins, and straws around the business. She was asked to leave and yelled at several patrons. The bartender, Heather M. Crisp, F/W (18-140), did not want Garcia arrested but did not want her back in the business. Garcia was transported to her residence. Garcia's friend, Michelle R. Bingenheimer, F/W, was also highly intoxicated and given a courtesy ride to her Aunt's residence. The business was in violation of WA-9.02(1) for selling alcoholic beverage to an intoxicated person. No citations were issued per this incident.

**NO VIOLATION**

**Caller: Owner – Mary M. Pakula**

**Disorderly Conduct:** On 07/18/2017 at approx. 1740hrs, officers responded to Tap City located at 7207 W National Ave to investigate a trouble call. Upon arrival, I spoke with Latoya R Brown F/B and Victoria E Brown F/B who advised they were involved in a confrontation with the tavern owner at Tap City identified as Mary M Pakula F/W. Victoria and Latoya advised they were involved in the altercation over parking in the business lot. Mary advised that her parking lot was full from patrons parking at the tavern and that she did not have space for Victoria and Latoya's vehicle. Mary advised Victoria and Latoya to move the car when the verbal altercation broke out prompting police contact. Both Victoria and Latoya were advised not to park in the lot or in the future they could receive trespassing citations. Mary was advised not to approach trespass parkers but rather to contact the police so citations could be issued. Mary was cooperative on scene however Victoria and Latoya were argumentative, loud, boisterous, and verbally uncooperative.

evaluation. A search of Laura's purse revealed 0.4 grams of marijuana and other drug paraphernalia. Laura became responsive at AWAMC, however denied any recent drug use. Laura was arrested for Poss. of Marijuana (THC) and Poss. of Drug Paraphernalia. Laura signed a PR bond and will be issued citations by mail. Laura remained at AWAMC for further evaluation and was ordered into WAPD for booking on 07/25/17 at 1500 hours. This incident was reviewed by Sgt. Manthe.
