AB606 CABLE CONSUMER REPAIR BILL

FAVOR, with changes as follows:

- (1) Have the State franchise renewed every 10 years rather than 5 years.
- (2) Require the video service provider to reach 90% of the households in 24 months rather than 18 months.
- (3) Require the video service provider to maintain PEG monetary support at 1% or what monetary support is currently in place.


