West Allis Community Communications Corporation (WACCC)

Date: 2/27/09

The WACCC funding is only in effect for two more years according to the State Franchising Legislation, so they have been active in working with a Statewide Public Access Association to promote new legislation to secure their funding beyond the current sunset period.

On the programming level the WACCC has produced 53 programs in the fourth quarter, enlisted six new members and had 10 people attend their workshops in field and studio production, computer editing and producer classes.

The WACCC had a presence at a number of events in the fourth quarter such as, West Allis Car Show Downtown, Hunger Task Force 2008 Conference, Breakfast of Thanks and Giving, League of Women Voters Meetings, Young at Heart Christmas Concert, Chamber of Commerce Holiday Fundraiser, Holiday on the Avenue and a live call-in Santa Show.

I recommend providing 4th quarter funding for the WACCC.
