PO Schmidt was told the owner is out of town and would contact the WAPD when the video is available.

NARRATIVE

Officer Schmidt reports:

INITIAL CALL

On 05/05/13 between 0130-0200 hrs, a reported assault took place outside of Brooklyn's, 9442 W. National Ave. Officer Stuettgen requested that I obtain the surveillance footage from the incident, because Brooklyn's is not open during his regular work hours. I was able to make contact with Brooklyn's owner, Dominic T. LaLicata (m/w, 10/16/74).

STATEMENT - DOMINIC T. LALICATA (OWNER)

On 05/15/13 at approximately 1515 hrs, I made contact with Dominic on the phone. Dominic explained he would not be able to retrieve the surveillance footage because there is an unknown problem with the equipment. He spoke with his employees who stated the subject in the incident was intoxicated, left the establishment, and shortly after fell down on the sidewalk. He was allowed back into Brooklyn's with staff to clean off his face. He did not want to seek medical treatment at that time. A cab was called for the subject and he left in the cab. Dominic was in the process of fixing the issue with his surveillance equipment.
