

### STATEMENT JASON DIXON (COMPLAINANT)

I responded to 1433 S 95 St to speak with Dixon about a noise complaint coming from Big Dog's Bar and Grill. The initial complaint had been reported to be loud music coming from the bar. Prior to meeting with Dixon, I drove through the alley behind to the bar to hear how loud the music was. I made contact with Dixon on his front porch. Dixon indicated that he had made several calls in the past for similar complaints of loud music and nothing had been done. Dixon indicated that he has had issues with the noise level since he moved into the home in January. Based upon the noise level I could hear coming from the bar at that point I asked if the noise had been louder prior to my arrival. Dixon indicated that noise level was still loud in his opinion and was just as loud before. I indicated to Dixon that I could hear the music, but did not feel that it was all that unreasonable. I tried to explain to him that I would speak with the bar staff and request they turn the music down.

Dixon disagreed with my observation of the noise level and questioned what would happen if he had his music up as loud. He made reference to there being a law that gave a specific distance (50 Ft) in which loud music could not be heard from. He advised that the music coming from the bar was clearly being heard from a greater distance than that. Dixon did not feel that it was appropriate that the bar continue to get warnings for the loud music. I asked Dixon if he was willing to go to court against the bar if a citation was issued. Dixon said he was willing to go to court. I advised Dixon that I would look into the businesses past noise complaints and cite the business if his claims were correct about all his past complaints.

When I traveled through the alley directly behind the bar I could hear the band through the closed rear doors. The drum rolls were the most obvious sound coming into the alley. The sound did dissipate slightly, but could still be heard at the complainants address. It was not really recognizable by the time it reached 1433 S 95 St, but it was clear that it was music. Although I was able to hear the music, I did not feel that it was an unreasonable amount of sound emitting from the bar.

There were two noise complaints (03/24/12, 11/13/12) that do not indicate who called. In that call the WAPD dispatch entry does not indicate who may have been the caller. A third complaint indicated a female named Mayra called (01/14/12). I checked for previous noise complaints at 9427 W Greenfield Ave prior to the time when Dixon moved into his home. I found only one other noise complaint attached to the bar address from the time period of 01/2010 to 12/2011.

I did locate Off. Vanderwerff's previous report # 12-008987, that indicated the Health and Licensing Committee would be made aware of the complaint. It also indicated that the aldermen would work with the business to resolve

#### CONTACT WITH GARY JACKOWSKI (BIG DOG'S OWNER)

At approx. 2330hrs I made contact with Gary at the bar. I explained to him the nature of the complaint and the fact that I intended to issue him a citation. Gary explained that he is trying very hard to keep the neighbors happy and did not believe the music was up to loud. He said he had worked with the alderman recently and it was agreed that his music levels were not unreasonable. Gary indicated that he uses a decibel meter to check the levels behind the building and on this day it was only in the 50's. On other days it has been in th 60's before he turned the band's speakers down, yet on those days there were no complaints. Gary is very frustrated by this one complainant as he has worked hard with the neighbors to insure he is being a good business owner. Gary advised that the many of the neighbors visit his bar and no one complains. He believes the complainant is singling him out and is harassing him with all these frivolous complaints.

I issued Gary citation # M-97036 for Disorderly Conduct-Noise. This citation was issued on scene.

# LITTLE HAVANA CIGAR SHOP

Just prior to making contact with Gary I heard music coming from this bar. I briefly made contact at the bar and advised them that they should turn down the band's speakers. I only make this notation because when I made contact with Gary, the bar manager at Big Dog's (Karen) tried to claim that it was actually the Little Havana Cigar Shop that was loud. I advised her that when I had responded to handle this call there was no loud music coming from the cigar shop. The music that the complainant and I heard was definitely coming from Big Dog's Bar and Grill.

#### CASE DISPOSITION

Based upon the previous complaints by Dixon and his insistence that the noise levels were unreasonably loud I issued the bar owner Gary Jackowski a citation for Disorderly Conduct. A tavern violation violation report was also completed as it related to this report.
