NOW THEREFORE, you, PAK Enterprises, Inc., are hereby summoned to appear before the License and Health Committee of the West Allis Common Council in Room 128 of the West Allis City Hall, 7525 West Greenfield Avenue, West Allis, Wisconsin, on February 27, 2007, at 6:00 p.m., or as soon thereafter as this matter can be heard, to admit or deny the allegations in the complaint. You may be represented by counsel on this date.

In the case of your failure to appear as required by this summons, the allegations in the complaint against you shall be taken as true and, if the License and Health Committee of the West Allis Common Council finds the allegations sufficient, a recommendation that your

license(s) be suspended or revoked will be made to the full Common Council. The Common

Council may then vote to suspend or revoke your license(s).

You are further notified that if you appear as required by this summons and contest the allegations in the complaint, a hearing will be scheduled at a later date before the License and Health Committee, at which time you may be represented by counsel, cross examine the witnesses who testify adversely against you, and present witnesses in your own behalf. A written transcript of said hearing shall be made and you may obtain a copy of the transcript of this

Kurt E. Kopplin, being duly sworn, on oath deposes and states as a complaint against PAK Enterprises, Inc. as follows:

- 1. That the complainant is a resident of the City of West Allis, is the duly elected Alderperson for the Second Aldermanic District in the City of West Allis, and makes this complaint at the direction of the License and Health Committee of the West Allis Common Council.
- 2. That the information contained in this complaint comes from the complainant's review of official records maintained by the City of West Allis and the West Allis Police Department, which records complainant believes to be reliable and accurate.
- 3. That PAK Enterprises, Inc. is the holder of a Cigarette License No. 1144, issued by the West Allis Common Council for the license period beginning July 1, 2006, and ending June 30, 2007, for the premises located at 3061 South 108<sup>th</sup> Street, West Allis, Wisconsin and does business under the trade name "Mobil".
- 4. That Mohammad Rafiq is the registered agent of PAK Enterprises, Inc.
- 5. That on October 15, 2006, at 3061 South 108<sup>th</sup> Street, West Allis, Wisconsin,

  Mohammad Rafiq sold or provided tobacco products to a person under the age of 18

  contrary to §134.66(2)(a), Wis. Stat., and §6.02(19), of the West Allis Revised

Municipal Code.

- 6. That PAK Enterprises, Inc. has violated the provisions of §134.55, Wis. Stat. of the Wisconsin Statutes and §6.02 of the West Allis Revised Municipal Code.
- 7. That on December 11, 2006 and January 15, 2007, PAK Enterprises, Inc. by its Registered Agent, Mohammad Rafiq was sent notices to appear before the License and Health Committee on December 19, 2006 and January 23, 2007, but failed to appear on either occasion.

WHEREFORE, Kurt E. Kopplin requests that PAK Enterprises, Inc. be summoned to appear before the License and Health Committee of the West Allis Common Council to answer this complaint and, if the material allegations of the complaint are denied, that a hearing be held to determine whether the Cigarette License of PAK Enterprises, Inc. should be suspended or revoked.
