Daniel is not currently in custody for the above offense and an apprehension request has been completed. Further investigation in this incident will continue.

Jackson (F/W 12/24/76) to report Edward had been assaulted the night before by a known party, Daniel P. Blazejovsky (M/W 8/29/80). I spoke with Edward in the front desk office, where I received the following statement.

Edward stated last night he was hanging out with friends at Larry Michael's Bar on 8900 W Greenfield Ave. Edward stated at about 0030hrs, he went outside to smoke a cigarette with a known party, "Dan Big", later identified as Daniel P. Blazejovsky (M/W 8/29/80). Edward stated he and Daniel were smoking outside of the side door to the tavern on S 89 St.

Edward and Daniel began arguing. Daniel accused Edward of manipulating a mutual friend (would not elaborate). Edward said he and Daniel exchanged words and then Edward put his cigarette out and turned to go back to the front door of the bar because the side door locked behind him. As soon as Edward turned his back toward Daniel, Daniel came up from behind and struck Edward on the left side of his face. Edward said he was not sure what Daniel hit him with because it did not feel like his fist.

Edward said he was hit so hard he stumbled forward. While trying to regain his balance, Daniel struck Edward in the face several more times. Edward then fell to the ground. Once on the ground in the supine position, Daniel stood over Edward and repeatedly struck him in the face using both fists. Edward said he rolled to his stomach for protection, at which point Daniel continued to strike Edward, hitting him in the back of the head.

At one point, Daniel stomped on Edward's right hand, causing the ring he was wearing to cut into his finger.

Edward said the bartender, Alma came outside and Daniel fled the scene on foot in an unknown direction. Edward did not know where Daniel went after the assault.

Edward and Alma then went back inside the bar to tend to Edward's injuries. Edward said Alma and several other patrons asked him if they should call the police or an ambulance but Edward said he told them not to because he knew Daniel and did not want to get him into trouble.

Edward spent the night at a friend's house. The next day he returned home where his wife, Melissa Jackson, insisted he go to the Emergency Room. Edward, being in severe pain at this time, agreed to go to the hospital. Once at the hospital, Waukesha Memorial Hospital, nurses and the attending physician encouraged Edward to report the assault to police. Once Edward was medically cleared, Melissa drove him straight to the WAPD to report the incident.

Edward described Daniel as white male in his early thirties, 6'1"-6'2" tall, about 195lbs, blonde hair and blue eyes. Edward only knew the offender as "Dan Big". I asked if Big was a nickname or Daniel's actual last name. Edward said he was not sure if that was Daniel's last name. Edward said he also knew Daniel's father, "John Big". A search of locals did not provide any matched to Daniel Big or John Big.

Edward said Daniel used to be a bouncer at Larry Michael's and the owner, Larry M. Beilfuss (M/W 2/24/54) would be able to provide Daniel's current contact information.

LACK OF CONSENT

Edward did not give Daniel consent to strike him repeatedly causing pain and multiple injuries including a broken orbital bone.

INJURIES/DIAGNOSIS

Edward was able to provide me a copy of his discharge paperwork from Waukesha Memorial Hospital, where he was treated for his injuries resulting from the above assault. A summary of this paperwork is as follows:

Date of visit: 10/26/14 Attending Physician: Andre J. Szymanski, MD

Diagnosis: Fracture of Orbital Floor, Blow-out, Left, Closed, Initial Encounter

A copy of the above paperwork was scanned and attached to this report.

On 10/31/14 at about 2030hrs, Edward called the station and stated an X-ray of his right foot revealed 3 broken bones. Edward wanted his injuries updated in the report.

CONTACT WITH LARRY M. BEILFUSS (BAR OWNER)

On 10/26/14 at about 2200hrs, I called Larry M. Beilfuss (M/W 2/24/54), the owner of Larry Michael's, and spoke with him about this incident. Larry stated he was not at the bar when this incident occurred but was made aware of the incident by Edward, a longtime friend of his. Larry provided me with the contact information for Daniel P. Blazejovsky (M/W 8/29/80) including his current phone number. Larry stated he did not know Daniel's exact address but said Daniel lived a block south of 29th and W Greenfield Ave in Milwaukee. Larry explained Daniel used to work for him as a bouncer but was let go for allegations of theft from the business. Larry stated Daniel still frequents the establishment and they are on relatively good terms.

Larry stated Daniel's father, John Blazejovsky, is in the bar every day after work and lives with Daniel. Larry stated John did not want to get involved in the investigation and declined to provide me with John's contact information. Larry

said both John and Daniel use the last name of "Big" with friends because they are big in stature.

Larry stated Alma A. Frye (F/W 2/20/71) was bartending when this incident occurred and he believed she may have witnessed the assault. Larry provided me with Alma's contact information.

IDENTIFICATION OF OFFENDER

Larry provided me with the name, Daniel Blazejovsky. Larry could not provide a date of birth or exact address for Daniel. Daniel was described as a white male, 6'2" tall, 200lbs, with blonde hair and blue eyes. A search through locals revealed a Daniel P. Blazejovsky (M/W 8/29/80) with a last known address of 2906 W Orchard St in Milwaukee.

ATTEMPT TO LOCATE OFFENDER

On 10/28/14 at about 2100hrs, WAPD officers responded to 2906 W Orchard St to attempt contact with Daniel.

CONTACT WITH DANIEL P. BLAZEJOVSKY (OFFENDER)

On 10/31/14 at about 2100hrs, I spoke with Daniel Blazejovsky over the phone. Daniel stated he is out of town for work and will not be back until Sunday. Daniel stated he would come into the station on Sunday to give a statement regarding the above incident. I informed Daniel if he did not come to the station on Sunday I would send the case down a warrant would likely be issued for his arrest. Daniel reassured he would be here on Sunday to give a statement.

On 11/3/14 at 1600hrs, I spoke with Daniel over the phone who stated he was leaving his home shortly to come to the station to give a statement.

BOOKING INFORMATION

On 11/3/14 at 1750hrs, Daniel Blazejovsky came to the station and was placed under arrest for Substantial Battery. Daniel was searched and escorted to the booking room for the booking process.

Daniel was mugged, fingerprinted and booked under booking #14-005095, for Substantial Battery. This case will be reviewed by the Milwaukee County District Attorney's Office on 11/4/14 at 0830hrs.

IN CUSTODY INTERVIEW

On 11/3/14 at 2045hrs, in interview room A of booking, I read Daniel his Miranda rights. Daniel stated he understood his rights and agreed to answer my questions regarding the above incident. This interview was recorded using Olympus Digital recorder P11 and media card P8-1, which was turned over to the Forensics and Technical Services Bureau for safekeeping.

Daniel stated he was working the door (as a bouncer) at Larry Michael's Club on Friday 10/24/14. Daniel said while working, Edward confronted him and started telling about how he (Edward) had sex with one of Daniel's friends and passed her around to his (Edward's) buddies. Daniel took offense to this but did not engage Edward because he was working.

The next night, 10/25/14, Daniel went to Larry Michael's for a drink. When Daniel walked into the bar at about 2330hrs, he immediately noticed Edward was sitting at the end of the bar with some friends. Daniel avoided Edward and went to the restroom. Edward followed Daniel into the restroom and confronted him. Edward asked Daniel, "So what's up with your girl?" Daniel told Edward to stop "talking shit" about her and leave him alone. One of Edward's friends then walked into the bathroom. Daniel said he was uncomfortable being alone in the bathroom with Edward and his friend so Daniel walked out to the bar.

Daniel then walked out the side door of the bar, which faces S 89 St, to smoke a cigarette. Daniel said he contemplated where he was going to go next because he did not want to stay at Larry Michael's and deal with Edward. Shortly after Daniel went outside, Edward came out of the side door and again confronted Daniel. Edward got in Daniel's face and said their mutual friend thinks Daniel is the one who was "talking shit." Daniel said they exchanged words and at one point Edward got within inches of Daniel's face and said, "What are you gonna do? Hit me? I got Latin Kings on my left and Outlaws on my right!"

Daniel said he pushed Edward away and Edward took a swing at Daniel. Daniel grabbed a hold of Edward's arm and struck him several times in the face with his fist. Daniel said Edward fell to his knees, at which point Daniel began walking away. Daniel said Edward began yelling for his friends and walking towards the bar door. Daniel, fearing Edward's friends would come out and assault him, ran up to Edward and struck him several more times in the face until he fell to the ground. Daniel said once Edward was on the ground he ran off so Edward's friends would not find him. Daniel said as he was leaving, the bouncer, Larry (last name unknown) came out of the bar front entrance and shouted, "What's going on out here?" Daniel said he kept walking to his vehicle and went home.

I asked Daniel why he did not report the incident and he stated he was concerned Edward's friends would retaliate. Daniel explained since the incident there has been talk on Facebook of Edward and his friends getting revenge. Daniel stated he

did not think he hurt Edward as bad as he did.

Daniel stated to the best of his knowledge, there were no witnesses to the assault. Daniel said the next morning he was fired from his bouncer job at Larry Michael's.
