RE: City Attorney's Report of Claim

Dear Council Members:

The enclosed claim has been referred to this office in accordance with Section 3.05 (6)(a) of the Revised Municipal Code. This office has examined the facts of the claim and the applicable law. Our Opinion regarding liability is as follows:

It is the recommendation of this office that the following claim be denied:

Walters Wrecking Inc. - Amount: \$5,085.70

This is a claim for the value of a chain link fence, as well as, the stands and clamps attached thereto, which was allegedly removed and/or stolen from a job site located at 7725-8001 West National Avenue (the former Laidlaw Bus Company site) in the City of West Allis, Wisconsin. On or about May 15th, 2007, the claimant, by the regular bidding process, entered into a contract with the City of West Allis for demolition work at the former Laidlaw site. Although the demolition work was completed in the latter part of 2007, the claimant, by contract, was required to install and maintain a six-foot high chain link fence around the entire excavation for safety purposes, which was to remain in place until the City Engineer released the fence for removal by the claimant. In March of 2008, the City Engineer, who had been making regular drive-by inspections to insure that a fence was in place, notified the claimant to remove its fence to allow other contractors on the site. When the claimant went to remove the fence, the fence had already come down and been replaced with a different fence under the authority of a contractor on site and unbeknownst to the City of West Allis. Needless to say, the claimant was not able to locate its fence at or near the job site and filed a claim on May 13th, 2008, against the City for the value of the missing chain link fence.

Our investigation into this matter indicated that the City of West Allis is not responsible for the claimant's fence as alleged in its claim. By contract, the claimant was to install the fence, as well as, maintain it until directed by the City Engineer to remove the fence. Although the City Engineer did routine drive-by inspections to make sure that a fence was in place, it was not the City Engineer's responsibility to maintain the fence or even be aware of the specific make and model of the particular fence installed by the claimant. It appears as though the claimant breached the contract with the City by failing to properly maintain its fence and is now trying to shift the blame for its own negligence onto the City of West Allis. Furthermore, if the claimant had any viable claim at all, it would be against the party who actually removed its fence, i.e. another contractor, and not the City of West Allis who at no time had any physical control over the fence in question. The claimant is simply trying to blame someone else for its negligence in this case.

Based upon the above, it is the recommendation of the City Attorney's Office to deny this claim pursuant to the provisions of Wisconsin Municipal Claims Statute 893.80.

Dear Mr. Ziehler:

I am legal counsel for Walters Wrecking, Inc. and hereby submit this letter with sworn affirmation as Walters Wrecking, Inc.'s 120-day notice to the City of West Allis for certain claims as outlined below:

As Against the City of West Allis: Breach of Contract for the authorized removal of fencing on the National Avenue site in violation of West Allis' contract with Walters Wrecking, Inc.

Walters Wrecking, Inc., a demolition and excavation company, which is located at 1300 S. Barker Road, Brookfield, Wisconsin, 53045.

On May 15, 2007, Walters Wrecking, Inc. (hereinafter "Walters"), entered into a contract with the city of West Allis for demolition work involving the following addresses: 7725 West National Avenue, 7741 West National Avenue, 7939-43 West National Avenue, 8001 West National Avenue, and 80** West National Avenue. Around late June early July 2007 Walters commenced demolition work on the site.

Per Walters' contract with West Allis, the following addendum was added:

ADDENDUM NO. 1

FENCING AROUND OPEN EXCAVATIONS

Installation of a safety fence around excavations will be necessary to safeguard against public access and potential injury. Temporary safety fencing shall be installed to prevent access to the site from the surrounding areas. The excavation area will be fenced with six (6) fee high chain link fence topped with three barbed wire strands securely bolted to the ground. This fence will remain in place following excavation activities until released for tear-down by City Engineer. *Contractor* will then dismantle fence. (Emphasis added).

Walters duly complied with this provision of the contract and arranged for the installation of fencing from Federal Rent-A-Fence during its excavation and after it had left the work site. In late March 2008, Walters received one voice mail message from a City of West Allis representative named Chris St. Clair who stated in this message that the fence had been dismantled and was waiting to be picked up. Soon after, Walters contacted Federal to pick up the fence. However, when Federal arrived on the site the fence and its material was gone. When a representative from Federal contacted Chris St. Clair about the missing fence, Mr. St. Clair, a public servant and representative of the City, replied that he did not "give a damn" as to what happened to the fence.

The current contractor on site indicated that it had no knowledge of the whereabouts of the fence and speculated that its fencing contractor, National may have removed it by mistake when it dismantled the fence. I spoke with a representative from National Fence by the name of Kay who searched her records and stated that National came to the West Allis site in January of 2008 and was directed by a person named Ed Persons or Parsons to remove the Federal fence and replace it with that of National's. According to Kay's records, National dismantled and stacked the Federal fencing material on site at the direction of "Ed" and left, but did not remove the Federal fencing materials. In addition, according to Kay, National has not been back on site since January, and there is information that the fence was still on site as late as March 2008.

On May 2, 2008, I spoke with Patrick Schloss of the City of West Allis, another public servant, who had very little information to share and indicated that I should take this matter up with the City Attorney's Office.

Walters did not receive a voice-mail message from the City of West Allis that the Federal fence was ready for pick up until late March 2008, despite the fact that according to National, the Federal fence had been dismantle and removed in January 2008. West Allis' handling of this matter is also contrary to its contract with Walters for Walters was to be responsible for the dismantling, not the City or another contractor. Unfortunately, Walters is being billed \$5,085.70 for a fence that was removed in violation of its contract and is now missing.

It is Walters' intention to file a claim for \$5,085.70 for the loss fence that was mishandled by the City of West Allis and the contractor on site in breach of its contractor with the City. Therefore, please be advised that this is Walters Wrecking, Inc.'s notice of claim relative to the missing fence.
