Re: Combination 1st and 2nd Quarter Funding for Educational Access

As with the public access channel the school channel is experiencing equipment repair and replacement difficulties due to the lack of funding. They have expressed their disappointment to state legislators regarding the provisions that eliminate funding in the pending state franchising bills.

Although the District's Information Specialist oversees their channel's operation, none of the funding from the City pays his salary. The funds support video club activities, salaries of the club advisors, two part-time assistants, and the purchase of new equipment. That is why the elimination of the funding puts Channel 13 in jeopardy. The District would like to keep the channel going, but with revenue caps and declining enrollment it would be most difficult to replace the funds from the City.

Despite these setbacks the clubs have continued to produce programs. Most recently the Central and Hale High School graduations along with concerts, athletic events, class projects, student skits and others. Pending projects include taping Recreation Department activities, a Back-to-School video and a program promoting the District and West Allis to potential residents and District employees. They are planning to operate as long as the funding continues, which now would be through the end of 2007.

Superintendent Walchholz and the Public Information Officer hope that the District and City can partner to preserve Channel 13 and the valuable programming it provides and the opportunities it presents to the students.

It is staff's recommendation to continue the funding for the educational access operations.
