NON-PAYMENT OF PERSONAL PROPERTY TAXES

Two years ago, the License and Health Committee granted me authority to enter into payment arrangements for delinquent personal property taxes with businesses so that they were able to retain their licenses. As per the agreement with Scardina's Bakery, Sue Scardina agreed to pay the remainder of her balance for all past due personal property taxes by June 30, 2010. Since signing the agreement, Scardina has been granted some additional time on several occasions to catch up on payments; however, the last payments that the City received were on August 4, 2010 for \$1,175.00 and on July 27, 2011 for \$3,000.00. Scardina's now owes \$45,325.71 for past due taxes – an amount of \$11,000 more than when the agreement was signed – and still owes the entire amount of 2008-2010 personal property taxes.
